forgotten man" as the Republican party prepares to select a Presidential candidate for the November election.


He definitely is getting the cold shoulder from G.O.P. big-wigs. His appeal to the rank-and-file of the party will amount to little more than a quixotic venture.

> On well-manured, highly fertile soil, use 200 pounds or more of 20 percent superphosphate to the acre. On moderately fertile soil, where legume residues have been ployed under, use at the row 300 pounds an acre of a fertilizer high in phosphorus and potassum, such as 0-12 - 12

On soils low in fertility, apply at


