Rocking of a widow's home and the whipping, or threatened whipping, of an unemployed man have given rise to talk of the Ku Klux Klan in the Cow Creek section where both incidents occurred.

The woman fled her home temporarily. Latest visitation of the "Klan" was Sunday night when several hooded men entered the home of Shelley Branham whom they said to have whipped.

None of the gang had been identified this week and no action had been requested from authorities, it was said here.

John Fred Williams, of Ashland, state superintendent of public instruction, will open the program with a "Welcome to the Big Sandy Valley." He will be followed on the program by Governor Clements.

"Big Sandy Coals and the Production of Synthetic Liquid Fuels," will be the subject of an address by Dr. Wilburn C. Schroeder, chief of the Division of Synthetic Liquid Fuels of the Department of Agriculture, Washington, D.C.

General remarks relative to the Flood control and Rivers and Harbors program of the Ohio River Division will be made by Major General J. C. McHaffey, Ohio River Division engineer.

Col. Harry Pockras, of Huntington, W. Va., technical assistant to the United States district engineer in Huntington, will give a technical presentation of the Big Sandy waterway.

The relationship to the Big Sandy waterway and retailers in the area will be the subject of an address by K. J. Day, president of the Kentucky Wholesale Grocery Company, Pikeville.

The president of the American Waterways Operators, Inc., Washington, D. C., Chester C. Thompson will discuss "Twenty Years of Technical Progress on Inland Waterways."

Other speakers to be on the program include E. L. Mullins, president of mine local No. 7916, Lookout, Ky., on "The Big Sandy Waterway and the Mine Workers"; Charles D. Jacobs, president of the Consumers By-Product Company, Pikeville, on "The Waterway and the Coal Operators"; and Col. W. E. Lorence, executive vice-president of the Ohio Valley Improvement Association, Cincinnati, O., on "The Waterway and Its Relation to Inland Waterways."

Representative W. Howes Meade, of Paintsville, Congressman from the Seventh Congressional district, is to give "A Look Into the Future."

Lexington, Ky., Aug. 16—If you don't like those sky-high meat prices—start a fish pond.

That's the thing to do, according to H. H. Thompson, of the University of Kentucky's College of Agriculture and Home Economics.

The most profitable acre on the farm could be a fish pond, Thompson said today.

He said a one-acre pond, properly made and maintained, would produce 400 to 600 pounds of fish a year at small cost.

Properly fertilized, an acre pond will support 100 bass and 1,000 to 1,500 bluegills, according to Thompson, who recommended these species for Kentucky.

But fish, like livestock, should be well-fed to be productive, the University staff member warned. They live largely on insects which grow in small plants called algae.

Scattering fertilizer in ponds stimulates the growth of algae—all of which means more feed for the fish.

Approximately 800 to 1,000 pounds of fertilizer a year is suggested for an acre pond, using it at the rate of 100 to 150 pounds a week. Mixtures recommended are 8-8-4, 10-10-5, or 20-20-10.

The premiums may be raised to cover "unforeseen contingencies," under this plan. But the policyholder must be notified 30 days in advance, and the raise approved by the state commissioner of insurance.

Anyone may join. This is one of the major differences between the new proposal and a previous plan the K.S.M.A. considered. The previous plan was to be sold only to persons with low incomes.

Dr. Miller said that under state law 51 per cent of the physicians in each county must agree to join before any policies may be sold in that county.

"It is hoped, as experience is gained, the provisions may be broadened," he said. The insurance corporation would consist of the association's house of delegates. It could either hire somebody to run the plan or pick an established insurance company to do it.

Some of the indemnities in this plan follow:

Removal of appendix, \$100; removal of carbuncle, \$25; amputation of single breast, \$50; reduction of dislocated shoulder (closed), \$30; removal of cataract from eye, \$75; removal of kidney, \$150; single hernia, \$75.

The policy provides a waiting period of 12 months for obstetrical cases. It pays \$40 toward cost of pregnancy and delivery of babies, with certain limitations.

She was graduated from the Woman's College, Richmond, Va., and after graduate work in Boston taught expression at the Virginia Institute before her marriage in 1903 to Mr. Langley, who was a member of the House for 19 years.

The Langleys moved to Pikeville in 1906, and after her husband entered Congress she served as his secretary, and from 1919 to 1925 was clerk of the committee on public buildings and grounds.

Mrs. Langley's interests also included a period as postmaster of Pikeville, and church and civic work. She was a former grand worthy matron of the Kentucky Eastern Star, a member of the Woman's Club, the Business and Professional Women's Club and the Baptist Church.

She also served as Pike county Red Cross chairman in World War I. Her tenure on the railroad commission extended from 1939 to 1943. She was defeated in a bid for reelection last year.

She also was active in the national cancer funds campaign, and served the drive as chairman in Eastern Kentucky for a number of years.

Other honors that came to her included that of first chairman of the Kentucky Women's Republican organization, alternate delegate-at-large to the Republican National Convention in 1920, district delegate in 1924, and delegate-at-large in 1928.

She is survived by a son, John W. Langley, Jr., of Pikeville, and two daughters, Mrs. Katherine L. Hinton, of Pikeville, and Mrs. Susanna Todd, of New Castle, Pa.

Funeral services were held Tuesday at the Pikeville Baptist Church, with burial in the Johnson Memorial cemetery.
