substantial difference in this county; whereas, Harlan will probably continue to be in trouble.

I am mentioning this only because people who oppose the small mines continue to do their best to put them out of business.

FARM NOTES By ROBERT M. JONES **County Agricultural Agent**

STRAWBERRIES

The first of the year is the time people generally take an inventory. This would also be a good time for farm people to stop and consider ways of increasing farm income. I would like to offer strawberries as a suggestion. Let's consider what are the opportunities. The total acreage of Kentucky and competing states are down from the high three year ago. In 1959 prices should be higher than the last two years, and will probably continue ris-

ing for three years. This puts the farmer, who sets strawberries this spring in a very favorable position.

Strawberries, unlike most agricultur · enterprises, require very little capital to get started. One acre could be established for \$100.00 and would produce profitably for four years, if properly cared for. If family labor is very little additional capital is needed. What can we expect from this acre? This would vary so much from farm to farm that it is hard to say. We have had yields from practically nothing to more than 400 crates per acre. If we use the 400 crate yields for example, and figure \$6.00 per crate, that would be a gross income of \$2400.00. Expenses, except labor, would include plants. insecticide, fertilizer, mulch, crates and marketing cost which might add up to \$750. This would
