





As your County Court Clerk and custodian of your important records, I feel that Floyd county does need a new courthouse. Our present courthouse is not large enough to take care of the expanding growth of our county, it does not provide adequate space for our attorneys to abstract, and we do not have sufficient filing space for our records.

The recent flood has greatly increased the danger of an already unsafe building, and I am vitally interested in the records contained in my office because I am responsible for the safety of these records. It was indeed a blessing to be able to save them during the flood, but if the present Courthouse should burn or collapse all of these records would be destroyed. If this were to happen, there would be no record title to any of the property in this county. If the property owner had lost or misplaced his original deed, he would have no evidence of ownership of property, and I am advised by the Bar Association of this county that it would be necessary for such a property owner to establish his title in a Court of Law. Contrary to belief, THERE ARE NO DUPLICATE RECORDS OF PROPERTY OWNERSHIP KEPT IN FRANKFORT or any place else.







The next time there is to be an election of Board Members no doubt the precincts will be shifted again into some other district. In this manner, some people may never get to vote for a Board Member.



These groups include hospital staffs, persons living in crowded conditions, such as those in institutions and service groups, and persons who have a special health risk, such as the aged, chronically ill, and pregnant women. available for anyone who wishes to be immunized

Dr. McGuire emphasized that those seeknig protection against flu now should not rely on protection from vaccine taken last year, nor from an attack of flu last year. "The duration of protection from vaccine is not more than a year at







State Farm Production **Showing Steady Decline**

In the last 35 years, he says, farm population has dropped from more than one-half the total population in the state to less than one-third of the total population. Kentucky's farm population over the past 35 years has decreased in actual numbers by about one-half million people. This change, plus others, indicate the changes taking place in Kentucky agriculture.

In 1950, he says, Kentucky had 218,000 farms averaging about 89 acres per farm; in 1954, it had 193,000 farms averaging 93 acres per farm. More than half the deline in number of farms from 1950-1954 was in farms of form 10 to 50 acres. Farms of 260 acres and above gained in numbers by about 15 per cent during the same period. Only 20 per cent of Kentucky farms were operated by tenants in 1954. The number of farms operated by tenants of farms operated by tenants has declined over a period of years. Seventy-two per cent of Kenucky's farms had a gross income of \$2,500 or less in 1954. Per capita farm income in Kentucky averages \$364 (1950-1955) while non-farm income averaged \$1,-614 per person or \$1,250 higher on a per capita basis. The average United States per capita farm income over the same period was slightly above \$900 while United States average non-farm income averaged slightly above



"DEVIL ANSE" HATFIELD AND HIS WIFE, LOUVICA CHAFIN HATFIELD

William Anderson Hatfield, leader of his clan in the Hatfield-McCoy feud, the most publicized mountain family struggle, was born in Logan county, W. Va., Sept. 9, 1939. He served for a while in a Confederate regiment in the Civil War with the rank of captain but later organized the Logan Wildcats, an independent group that operated on the Kentucky-West Virginia border.

Johnson (Johnse) Hatfield, son of the feud leader, was tried in Prestonsburg in 1898 for the murder of Allifair McCoy on Blackberry Creek. He was defended by the late Walter S. Harkins. Sentenced to life in the penitentiary, Johnse served a few years and was pardoned by Lieut. Gov. Thorne while Gov. J. C. W. Beckham was out of the state.

Devil Anse-died at home on Island Creek, Logan county, W. Va., Jan. 6, 1921, and the largest gathering that ever assembled at a mountain funeral attended the final obsequies. It was necessary to run special trains from Logan to carry the passengers.

From the floor, I. C. James, president of Harrodsburg Historical Society, nominated an opposing slate headed by Dr. Clark. For a brief while the old Senate Chamber rang with flowery oratory as various members rose to extol the virtues of their respective choices.

James proposed, in the interest of democratic fair play, that each of the opposing offices be voted on separately.

This was rejected by Dr. Jillson on the ground that "we never have done it that way, and besides it takes too long.

Then came the vote-30 for Dr. Jillson and 29 for Dr. Clark, with Dr. Jillson again ruling that the two Harned boys were ineligible to





Foreign Scientific Aid **Contract** Renegotiated

The University of Kentucky's multi-million dollar contract to provide engineering and scientific aid to the University of Indonesia at Bandung has been renegotiated and extended, and its value has been increased by \$1,-119,300.

Signing of the new contract was announced last week by Dr. Merl Baker, co-ordinator of the agreement, which is between UK and the International Co-operation Administration, an agency of the United States State Department.

Under the new provisions, UK will send 20 professors in various fields of science to the Bandung school. Seventeen are already there.

Two Research Grants Awarded U.K. Professor

Two research grants totaling \$51,176 have been awarded to Dr. Morris Scherago, head of the Department of Bacteriology at the University of Kentucky. Announcement of the grants was made by Dean M. M. White, of the College of Arts and Sciences and Dr. Merl Baker, director of the Kentucky Research Foundation. The KRF will administer the contract. One of the grants involves a

study of the sensitivity of leucocytes, or white blood corpuscles, to the products of microorganisms. Worth \$7,916 over a three year-period, it was given by the National Institute of Allergy and Infectious Diseases. The other grant is from the Kentucky Heart Association.





> to needy families and institutions. The same staples are issued to schools, but are supplemented with fresh fruit in season, canned vegetables, and frozen meat and fowl. A qualifying family of five receive the following issue of food once a month:

Six nourishing staples are issued

Cheese, 2 pounds a person; powdered milk, 3 pounds each; rice, one pound each; meal, 4 pounds each; flour, 4 pounds each; butter, 11/2 pounds each.

The wholesale value of these rations to the family are: cheese, \$54; milk, \$43.20; rice, \$6.60; meal, \$16.-80; flour, \$20.16; butter, \$62.40. The wholesale total of \$203.16, if marked up 30 cents, becomes around \$265 at the retail level.

Needy individuals accounted for 25,382,230 pounds of surplus in the year ending June 30, with wholesale value of \$4,363,835. Institutions accounted for 2,271,288 pounds; wholesale value, \$481,276. Schools accounted for 8,177,176 pounds; wholesale value, \$2,462,646.

SPOON BURGERS

Try this: Ingredients needed are: 1 pound of ground lean beef. 1/4 cup finely chopped onions. 11/2 tsp. hot fat. ½ cup milk. 1 tsp. salt. 1/8 tsp. pepper. 1/2 cup catsup or chili sauce. Brown the ground beef and onions in a skillet with the hot fat. Stir evaporated milk, salt, and pepper into meat mixture. Cook and stir over low heat until mixture thickens. Remove from heat and stir in catsup or chili sauce. Spoon meat mixture into eight split buns or spoon over slices of bread. Serve hot.




