She died in 1831 but Adam Wiley was alive when Connelly took notes on the story. Wiley and Connelly made several trips to the area and explored the entire Little Mud Lick Creek valley. Adam Wiley pointed out exactly where his mother was held.

Decades passed, history was little read and tradition took over. The place on Big Mud Lick Creek was shown to tourists and history-minded persons as the actual cave. No one questioned it until a few weeks ago when the Scouts proposed to set up a trail along Mrs. Wiley's escape route to Harman's Station near the mouth of Johns Creek.

The trail had to begin, Scout leaders said, at the actual cave. Last week two Eagle Scouts, James Goble and Carl Chaffins, from Troop 27, Prestonsburg, with David Stephens, Jr., of Radio Station WPRT and the writer, of The Times staff, went to. Little Mud Lick Creek falls area to find it. They carried topographical sheets of the area and Connelly's history. "The Jenny Wiley Captivity and the Founding of Harman's Station," which was published in 1910.

Little Mud Lick Creek falls were created many millenia ago when the stream cut its way through a mountain backbone to join Big Mud Lick Creek, a tributary of Big Paint Creek. The canyon sides, from the top of the mountain to the deep recesses of the creek, are draped with giant hemlocks, poplars, ferns and rhododendron.

There are three levels to the east side of the canyon walls. either easily traversed horizontally and entered only near the first of the three major falls. The group chose to explore the stream bed first. It would be highly dangerous to attempt when the creek was full but Thursday of last week the water was low. The two Scouts clambered over the rocks, let themselves down over the falls and negotiated the giant sandstone poulders in striking contrast to their accompanying elders. Coming out at the end of the falls area, they began to explore the first level of caves or rockhouses. One was particularly intriguing, for at many places on the walls the heads of horses had been carved. It was named Horse Head Cave.

"My great-grandfather was named American purchaser. Lyttleton Tazewell Harris. He had

two older half-brothers, Henry C. Harris and James Harris, L. T. Harris was born in Tallahassee, Florida, in 1821. I do not know the birthplace of the other two but the family moved to Plaquemines Parish, Louisiana, after 1821. All three of the boys went to Kentucky and became lawyers. Henry C. was already practicing at Prestonsburg when Lyttleton T. arrived in Kentucky and he studied law under his older brother at the same time that John Milton Elliott was studying under him. L. T. Harris met Mary Jane Elliott, the sister of John M. Elliott, and were married. Elliott and Harris became law partners. "Later, Henry C. Harris and

James Harris lived in Covington. and L. T. Harris moved to Louisiana and practiced in New Orleans.

"Since all of these Harrises moved away and apparently left no heirs in Prestonsburg, one can see why no one could ever find a connection between Henry C. Harris and the other Harrises in your area.

"As far as we know H. C. Harris had only one child, Mary Louise, who married Judge Robert Carter Richardson, of Covington, in 1859. The records indicate that they had four children and I am presently engaged in trying to locate some of the descendants at Covington to see if they can add to my Harris antecedent information.

"Mary Jane Elliott Harris died in 1916 at 90 years of age at Harris Plantation, Monroe county, Arkansas, and is buried in the Harris family area of Elmwood cemetery, Memphis, Tennessee. Her husband, L. T. Harris served as Colonel of Louisiana cavalry, Confederate Army, after moving from Kentucky to New Orleans. He moved to Miss issippi after the war, died in 1882, and is buried at the same place.'
