

# **OLD AGE ASSISTANCE**

The average Old Age Assistance recipient today gets \$12.80 more on the month than he did in 1959 under Chandler. If an Old Age recipient paid 3% sales tax on every penny of the \$12.80 more he gets today it would only be 38c a month, leaving \$12.42 more on the month today with the sales tax than ever before.







It has never regretted that stand. ### This Is a Sound Ruling

The Times believes (1) that those who are unable to work or who cannot find work should be supplied food, and (2) that those who will not work should not eat.

So it is that we hail the ruling recently announced here to the effect that those who refuse employment and are able to work will be denied food stamps.

We do not believe that it was the intent of the fed-eral government or, more specifically, the U.S. Department of Agriculture, to encourage any able-bodied man or woman to live on food-stamp largesse and re-fuse to earn a living if the opportunity is presented. Farmers have complained that food stamp recipients

have refused work and that they cannot employ help with their crops. The new ruling should correct that situation.

What this country needs is a public works program, but until that comes along it must make the best of what is at hand. And the best is not a program to encourage idleness and sycophancy.


There is idle land in this county that could make busy hands. Planting time is near, and these who can work should be supplied plots for gardens. Many need instruction, some may need seed. Give them both. But let them work. Let them have a normal human's share in this business of living.

Those who are sick or enfeebled or in any way in-capacitated must be fed and clothed. We cannot excuse ourselves by a cold refusal to help because some, even many, have taken advantage of governmental agencies and even their friends and neighbors by pleading poverty and need when they could have helped themselves. The cry of real human distress must never be ignored.


But the only real help that can be given the able-bodied is work to do, a living wage, an opportunity to become self-supporting and a self-respecting member of the race and society.

I have been school bus driver in Floyd county for 2 years and the Transportation Supervisor will tell you he had no complaints as to the manner of my driving or otherwise until recently when the school principal, Phillip Dingus, of Allen Graded School and the Superintendent of Schools learned that I was supporting A. B. Chandler and Harry Lee Waterfield. I was first called into the Superintendent's office and questioned concerning certain political items which I had signed as Co-Chairman for Chandler and Waterfield. I informed him of my rights as a citizen to support the candidate of my choice and that I was supporting Chandler and Waterfield.
