## Christmas Season Also Accident Time, State Drivers Told

Frankfort, Ky. - The Christmas season is a joyous period for everyone but it is a potential traffic accident generator because of the rush to complete shopping chores, drinking at parties, early hours of darkness and often inclement weather, says Charles B. Jones, director, Division of Accident Control. Department of Public Safety, ir a warning to motorists.

Drivers were asked to use extra caution during the holiday period.

"They must use good sense in driving to stores on last minute shopping errands," he said. They should keep their vehicles in tip-top shape for operation in winter storms often hit this area about this time."

"If the streets and highways are slippery, a void sudden moves." the state director warned.

"When you suddenly come upon an icy patch of pavement he sure your front wheels are rotating if you are trying to turn. he said. "Hard braking will lock them. Then the tires act like sled runners and you slide straight ahead. You feel helpless sitting with your wheels cramped right or left while you slide straight into a ditch-or into the path of another car. 'Pump' your brakes and slow down, then coast over the ice.

"Care and common sense will go a long way toward assuring a safe and Merry Christmas for you and your loved ones," Jones concluded.







