HIGH COURT **DENIES STUDY** 

Tecon Loses Fight For Federal Refund **On Taxes, Penalties** 

The Supreme Court has refused to review litigation in which Tecon Engineers, Inc., a Kentucky concern, sought refund of federal income taxes and penalties totaling \$383,544. The firm contended the taxes

Cliff Free Will Baptist Church, were erroneously collected. The U. S. Court of Claims dismissed the concern's suit "with prejudice," meaning the action could not be filed there again.

The Supreme Court on January 17 declined to act on a Tecon appeal that questioned the dismissal. The high court made no comment about the case.

Tecon's appeal noted that it had filed the same refund claims in the U. S. District Court in Frankfort. The appeal questioned if the Court of Claims should have relinquished jurisdictioninstead of ordering dismissal-

in view of the claims filed in the Frankfort court. Tecon Engineers, Inc., is one of several engineering firms

headed by William H. May, of Frankfort. May has sought to recover \$423,053 he had paid in income taxes, interest and penalties assessed against him and

his engineering firms between 1956 and 1959.





## **Two Buildings Burn Almost Simultaneously** At Pikeville Recently

Pikeville, Ky. - Two buildings within 2,000 feet of each other were destroyed here last Thursday by apparently unrelated fires that broke out almost simultaneously. Fire department officials said a faulty flue in a coal stove caused the blaze that destroyed the one-story frame house occupied by E. J. Robinson. The second fire-accompanied by an explosion-occurred when fumes from a tank truck being emptied were touched off by a natural gas heater inside the scale and storage house owned by an oil company. Four men were inside the building, but only one, Ed Kimberland, was injured.
