## Selective Service Boards Directed Not To Induct Registrants, Aged 38

**Older Men Scheduled For Civilian Work Under New Order**

Washington, Dec. 5—President Roosevelt today transferred Selective Service to the War Relocation Authority, under Chairman Paul V. McNutt, authorized priorities over civilian employment and suspended voluntary enlistments in the army and navy at the same time. The War Department ordered suspension of induction into the army of all men 38 or older.

## Four Floyd Countians Gain Draft Respite Because of Rape

At least four of the 103 Floyd county draft registrants slated to leave here Tuesday, Dec. 15, for final examination at Huntington, W. Va., for induction under selective service, will either be replaced by younger men for the Dec. 15 call or the draft Board's December quota of men will be less than 103.

Neither draft board here, however, had been officially notified Monday to refuse voluntary army enlistments. Although a Washington dispatch had indicated this was expected.

Harry T. Hill, clerk of Draft Board 44, said that selective service headquarters in Louisville has instructed the Board here not to forward for induction any registrant 38 years of age or older, even if such action resulted in failure of the Board to meet its December call.

These instructions from Colonel Fred D. Bush, Kentucky director of Selective Service, followed executive order of President Roosevelt stopping the age-limit of draftees at below 38 and calling a halt to voluntary enlistments in the armed forces.

The four who will be exempted because of age from the December call are: Cecil Irving Priddy, Pyramid; Melvin Owen, Rainer; Craig Newsum, West; Prestonsburg; John C. Wells, Auster.

Although a number of married men leave Dec. 15 for army induction, none of these, except volunteers, married before Nov. 1940, it was said. The selectees who pass the final physical examination at Huntington will be permitted a furlough of only seven days, the former 15-day furlough rule having been discontinued December 5.

Listed as delinquent this week by Draft Board 44 are: Parnes Lemport, Prestonsburg, for failure to report for physical examination at Athens, Ga.; and William Smith, Prestonsburg, now in the merchant marine, for failure to report here for induction November 5, as instructed by the War Relocation Authority.

**Mrs. Hattie Williams Is Fatally Burned In Gas Explosion**

Burned by an explosion of gas in her home at G. O., Thursday last, was Mrs. Hattie Williams, 64 years old, who died four hours later at the Martin General hospital.

Mrs. Williams left the gas burning in the room where she kept her clothes when she walked, a few yards away, to the home of her daughter, Mrs. Bertha Parrish; returned, shortly afterwards, to find the room filled with gas. When she struck a match to re-light it, a terrific explosion which wrecked the room, blasting the ceiling, which caused her to fall. Her husband, Lewis B. Williams, sought to save her by throwing a quilt about her.

A daughter of the late John S. and Nancy Ann Crouch Williams, she was a native of Boone county, W. Va., but had resided at G. O. for the last year. She had been a devout member of the Missionary Baptist Church for the last 25 years and was known as one of her community's best women.

Besides her husband, Mrs. Williams is survived by one son and two daughters: Gilbert L. Williams and Mrs. Bertha Parrish both of Wayland, and Mrs. Ruby Robinson, Lima, Ohio. She also leaves four sisters: Mrs. Beatie Marcum, Chesapeake, W. Va.; Mrs. Virgie Nelson, Winifred, W. Va.; Mrs. Mary Miller, of West Virginia; Mrs. Anna Layman, Bedford, Illinois.

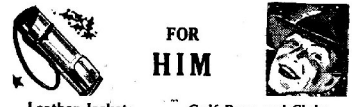

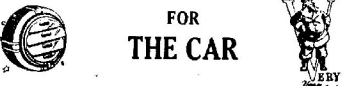

vice," now held by Maj. Gen. Lewis B. Hershey, but held Hershey subject to McMurtry's authority. All local draft boards were directed to continue functioning as in the past, except that they will get their future directions from the W.M.C.

The ban on volunteer enlistment does not apply, however, to anyone who has already on file a bona-fide application for enlistment, if his enlistment is completed within the next 10 days.

McMurtry was also made a member of the Economic Stabilization Board, which is headed by James F. Byrnes.

A proposed order to strengthen federal control over food was also expected soon and high administration officials, speaking anonymously, said that Secretary of Agriculture Wickard would be given the job of food administrator.

In its order suspending induction of men 38 or older the War Department announced that certain enlisted men of that group now in the army and unable to perform military service satisfactorily may be honorably discharged if they are qualified otherwise to assist in the war effort.

The department said the action was taken "as a result of experience gained during the past three years which indicates that men 38 years of age and over are generally physically less able to withstand the rigors of present-day combat activities and that many of these men can make a more effective contribution to the war effort in industry rather than in the army."

The order was similar in most respects to a recent ruling of the army concerning men in the 45-year-old group. Suspension of the induction of men 38 years and over will be effective "until further notice."

"It may be necessary," the department said, "to waive this suspension from time to time in order for less able to obtain skilled men not otherwise available and if this becomes necessary every effort will be made to secure the required men from other than essential war industries and occupations."

The department also outlined these provisions with which men 38 or over must comply to obtain honorable discharges which they may be granted if now in service:

(A) The soldier must voluntarily request discharge in writing to his immediate commanding officer.  
(B) The soldier must be handicapped by advanced age, 38 years or over, to such an extent that his usefulness to the army is secondary to that of industry.  
(C) The soldier must present satisfactory evidence that he will be employed in an essential industry, including agriculture, if he is discharged from the army.

"Each application for discharge under the above conditions," the department announced, "will be considered on its individual merit and no soldier will be discharged unless a suitable trained replacement is present and available."

The department emphasized that the provisions of discharge of men 38 years of age and over are subject to revision or revocation at any time and that acceptance of an application for discharge under the above conditions will not be considered as a promise to release any individual.

"Acceptance of an application means merely that the soldier's request will receive consideration. It was emphasized that any discharges from the army under this plan will be granted in furtherance of the war effort and not as a right of the individual."

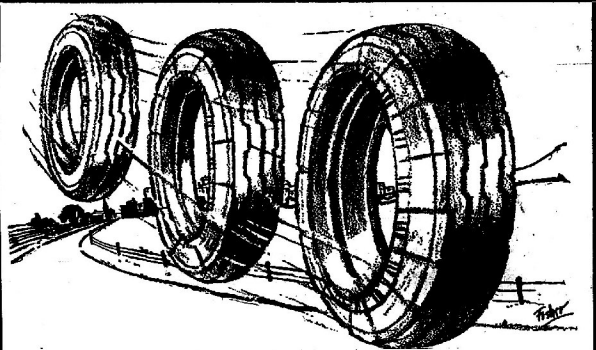

In order to help clarify this situation we are giving the simple rules governing eligibility in the four principal classifications.

- "A" BOOK (240 miles or less)—Entitled to Re-caps if tires need re-capping. If present tires are not fit to be re-capped, owner is entitled to: (1) Used Government tires or (2) Grade 3 new war tires.
- "A"-B" BOOK (560 miles or less)—Entitled to Re-caps if needed, or, if present tires are not fit to be re-capped, owner is entitled to Grade 3 new war tires, if present tires cannot be re-capped.
- "C" BOOK (661 to 1,000 miles)—Entitled to (1) Re-caps if needed or (2) Grade 2 new tires, if re-capping impossible or (3) Grade 3 new tires.
- "C" BOOK (1,000 miles and over)—Entitled to Re-caps if re-cappable or, if tires are not fit for re-capping, are entitled to (1) Grade 1 new tires, (2) Grade 2 new tires, (3) Grade 3 new tires.

**PLEASE NOTE:** No one is entitled to a new tire of any grade if their present tires are fit to be re-capped.
