5TH WAR BOND DRIVE QUOTA IS \$870,000

Drive Starts June 12; Judge Hill To Lead Floyd Bond Sales

For the Fifth War Loan drive, which will be launched throughout the nation Monday, June 12, Floyd county has been asked to buy \$870,000 worth of Bonds, County Judge E. P. Hill, chairman of the drive in this county, said last week.

Judge Hill added that only the patriotic support of every citizen will enable the county to reach this goal. He plans a thorough organization of workers for every part of the county but foresees difficulties lying in the fact that all schools of the county, which in past War Loan drives did such excellent work, are now closed.

Commonwealth's Attorney John Allen is vice-chairman of the Floyd county drive.

Of the \$870,000 to be sold, approximately \$235,000 is to be bought by individuals.

"Volunteer workers interested in the men who are doing the fighting and naturally expect us to do the buying are wanted," Judge Hill said.

All purchases of Bonds made by Floyd counties, whether in the armed force or employed outside the county may be credited to this county if the purchaser will request that this be done. Bond buyers and leaders here urgently request that Floyd county citizens buying bonds elsewhere make request and help Floyd county.

The nation's quota has been set at \$16,000,000, an increase of \$200,000,000 over the amount asked for in the fourth drive. Floyd's quota in the forthcoming drive is \$145,000 above the Fourth Bond quota. In all the county raised \$100,000 more than its quota during that drive.

Although the actual drive will run from June 12 to July 8, inclusive, all sales of series E, F and G bonds, and Tax C savings notes made during the period from June 1 to July 31, inclusive, will apply against this quota. Sales of all other bonds may be processed during the period from June 12 to July 8 to apply on the quota.

MINE LOCAL PAYS TRIBUTE

Local Union No. 5885, United Mine Workers of America, at Wayland Sunday paid tribute to its members and the sons of members who are in the armed forces.

Principal address of the afternoon was delivered by Dr. Elmer E. Gabbard, of Buckhorn, Ky. Other speakers were County Superintendent Town Hall, County Attorney W. W. Burdick and Bart Bloomer, UMW's field representative.

En Route to Cemetery, Woman Fatally Hurt

Thrown from a horse Saturday as she rode to a basket of flowers to decorate the grave of her husband, George Hicks, 66-year-old Rita Hicks was fatally injured on Salt Lick Creek, a few miles from Bosco. She died of internal injuries while being taken in an automobile to a hospital.

The body was taken to Moustie, Knott county, where burial was made Monday under direction of the Ryan Funeral Home.

Reel Gohorn, also of the Salt Lick section, recently suffered a broken jaw and other injuries when thrown from and kicked by a horse. He was taken to the Stumbo Memorial hospital, Lockett, and is recovering.

X-RAY CLINIC IS ANNOUNCED

The annual spring tuberculosis x-ray clinic will be held in the office of the Floyd County Health Department June 13. It was announced this week by Dr. Marvin Randall, department director.

The clinic will be conducted by Dr. John B. Floyd, of the State Board of Health. Because of the nominal price of \$125 per picture, health authorities expect all known sufferers from tuberculosis and all contacts with the disease to avail themselves of the services of the clinic.

A Floyd County Board of Education ruling requires its teachers to produce proof of physical fitness, although all who taught last year have already been examined. New teachers this year will be required to undergo examination, including x-ray of the chest. The clinic, it is said, will be available to all these.

A 1700-ton-a-day operation employing 245 men, the Princess Elkhorn No. 1 mine at David was recently commended by Federal Inspector Edward Thomas for making a number of safety improvements since the initial Bureau of Mines inspection in July, 1942, and for reducing lost-time accidents from 25, including two fatalities, in 1942 to 25 with no fatalities in 1943.

Recent improvements included the regular removal of coal dust from the triple head house, and conveyor line, and the elimination of other surface hazards; use of adequate cap pieces on posts and employment of steel bars to pry down loose rock; permissible explosives and safer methods for handling and firing them; intake-air ventilation for haulageways; good maintenance and effective blocking of mine cars; abolition of several dangerous haulage practices; wearing of respirators by men applying permits to gas; trolley and power wires; and first-aid and mine-rescue training for employees.

Inspector Thomas recommended the following safety improvements: underground setting of safety posts at working faces and more frequent roof testing, enforcement of rules limiting the width of entries, and the use of permissible, shock-absorbing units in multiple blasting. He also suggested shelter holes at points where rock is gobbled along haulageways, safety equipment for locomotives and trips, maintenance of permissible electrical equipment in permanent condition, use of ground-circuit protection for electrical equipment, and the removal of bare power feeder wires from return air.

LIGHTEST CALL SINCE FEB. '42

Made by Draft Board 45; Induction Quota of 6 Assigned Board 44.

Draft Board 45's lightest call for Floyd conscripts for the armed services since February, 1942 was issued this week as 33 registrars were notified to leave here June 8 for preliminary examination at Huntington, W. Va.

MINING FIRM, WORKERS ROW OVER OFFICER

Strike of 275 Ruled Illegal by Mine Union; Miners Allege Abuse

Approximately 275 mine-workers at the Princess Elkhorn Coal Company's No. 1 mine were idle this week as they sought by a strike to force the dismissal of Nelson Kendrick, as special officer in the mining town.

After Roy Hammonds, a mine-worker, had been jailed here Saturday night by Kendrick on a drunk charge, the company's No. 1 mine ceased to operate. The No. 1 mine's day shift worked Monday, but has been idle since.

Special Officer Kendrick and others said Hammonds was intoxicated and firing a 22-caliber automatic rifle in the camp Saturday evening prior to his arrest. The version of the arrest said that he and Kendrick tussled for possession of the rifle and that Kendrick struck Hammonds on the head with a revolver after telling him three times to release the rifle.

When E. D. Zornes, mine superintendent, returned Monday morning to the local union there reported he had been asked to call a meeting of the union and to decline to do so on the ground that the matter was not one of the local's jurisdiction.

Both United Mine Workers field men and a representative of the Solid Field Administration Monday visited David and advised the men to return to work.

Tom Hanes, Pikeville international UMW representative, who arrived here Wednesday with mine workers' representatives in an effort to effect a settlement of the dispute.

A tense situation developed in the town Sunday and Kendrick for a time was said to have been threatened by angry miners. He remained in David and the coal company stood firm on its refusal to discharge him.

47 LOST WORK IN ONE DAY

At Wayland as Result Of Deputy Constables' Work, Roney Declares

Declarator that resolution drafted and adopted by Floyd mine union members and others, and published in last week's issue of THE FLOYD COUNTY TIMES, was not intended to "cast any reflection on the administration of either Sheriff Sturgill or County Judge Hill," Tom Roney, Pikeville, International board member, United Mine Workers of America, cited a day's work lost by 47 men at one time from the Wayland mine in this county because of activities of deputy constables and at the same time alleged that these officers are acting in a selfish manner in order that a few fees may be grabbed up.

"Mr. Roney's statement follows, in part: . . . I wish to state that in the meeting in which the resolution was adopted, there was only one complaint against any deputy sheriff on Mr. Sturgill's payroll.

"The intention of the resolution was not to cast any reflection upon the administration of either Sheriff Sturgill or County Judge Hill."

WILLIS NAMES BOYD DIST. PAROLE AGENT, EFFECTIVE JUNE 1

W. B. Boyd, of Prestonsburg, last week was named Parole and Probation officer for the 31st judicial district and began work today (Thursday).

Mr. Boyd succeeds Bruce Martin, of Knott county, as parole officer in this district. After Mr. Martin, a holdover from the Johnson administration, resigned, this district was temporarily merged with the Perry-Leads district.

The post pays \$130 a month, with five cents per mile traveling expenses.

Bandages Made Here for Wounded 'So Pitifully Few,' Ashamed To Ship

"We have been asked by the War Department to ship at once all surgical dressings we have made, but we can't," Mrs. Lillian Keenan, director of Red Cross surgical dressing work, said Wednesday. "The number we have ready to ship," she explained, "is so pitifully small we are ashamed to ship them."

The War Department, Mrs. Keenan said, has called on Red Cross surgical dressing rooms of the Eastern area to supply 30,000,000 dressings a month, and Floyd county's quota has been tripled for the summer when the invasion of continental Europe is expected to be at its height.

Floyd county's quota for July, for instance, is 78,000 dressings. The county's average production, however, has been only 2,000 a week, Mrs. Keenan said.

An exception to this low rate of production was Tuesday night following the Memorial Day dedication here of the Floyd county Honor Roll. That evening, 24 women folded 1,225 dressings.

In addition to the room here, surgical dressing rooms have been opened in the Allen and Maytown school buildings.

THE GARDEN

By John S. Gardner Kentucky College of Agriculture and Home Economics

BEAN BEETLES Beans suffer from three foliage-eating beetles. The most serious, of course, is the bean beetle. It is for it that can make it impossible to grow any beans at all, any part of the season. Those angular, gnawed holes on the leaves are its sign. The other two are the Southern bean beetle and the spotted cucumber beetle. Both these make roundish holes on the leaves, but when they leave beans when their more favorite herbage (weeds perhaps) become plentiful. Their damage is unappreciated when beans are growing in cool weather, but it is rarely fatal. The rule applies that any leaf-eating insect can be stopped by spreading poison before it, but because of the tenderness of the bean foliage, none of the arsenates are safe to use except magnesium arsenate in a spray, two rounded tablespoons to one gallon of water, or, as a dust, one part to six of lime. Another dust that is safe is made of calcium arsenate, one part sulphur one part, lime four parts. The arsenates are human poisons, and none should be used after pods have begun to form. Use only rotenone dust or spray. Because of the cost and scarcity of rotenone, however, it should be saved until it must be used. For the Southern beetle and the spotted beetle, the dust or spray need merely be put on the foliage, when the holes begin, as these insects eat all the way through the leaves. However, for the Mexican bean beetle, the only effective plan is to on the leaves under side, as it feeds only there. For the Mexican bean beetle, too, a special schedule must be observed. Mark the dates on which it is spraying proceeds for 10 days, and the eggs hatch in about 10 days. Also, the recommended control materials hold their potency easily 10 days which makes the spraying or dusting schedule this: At the first appearance of eggs, dust or spray, and in 10 days, dust or spray again. This has been surrounded, all the egg-clusters of that generation, and in time to prevent the larvae from getting very far. Marking the dates on which spraying proceeds for 30 days ahead, prepares the gardener to cope with the next generation. In this state, in normal summer, there are at least two generations, and sometimes part of a third. If each is checked as it comes, the customary late summer holocaust of hungry Mexican bean beetles will not develop. Homemakers in Hickman county are adjusting work surfaces to correct heights in order to make kitchen work more quickly and easily done.
