All churches, the American Le-gion, clubs and other organizations have had free access to the courthouse to hold their meet-ings there at any time they wish to do so. During the time that I have been here I have tried to save the laxpayers every dollar that I could by taking care of the jail and courthouse. You are invited to inspect the courthouse and grounds to see how well and clean I have kept them.

I have a son, a grandson, a brother, numerous nephows and cousins serving in the armed forces. Some have been killed and some wounded. I know the problems of the service man and know how to help them when they are in trouble. No man in the service, and no returning ser-vice man will receive any bad treatment in or around my jail. I submit to you fathers and moth-ers the record I have made in giving aid to the service man.

The experience that I have had will enable me to make you a better Jailer for the next four years. I promise you the same fair, friendly, accommodating service in the future.
