

The other half of the total contributed was placed in the treasury of the Kentucky Chapter of the National Foundation. The Chapter is spending it for: (1) Relabilitation of the many victims of last summer's epidemic in the State; and (2), Media and hospital care for every victim of this decad discase who is unable to pay for such care, regardless of race or creed.
