




While the pain from the loss of life and property is still fresh for those in Pike County, the burden to county gov ernment is only just beginning.



When it comes to supplying the energy that powers our coun-try. Kentucky plays a bigger role than most. We represent just 1.4 percent of its population, but provide 2.3 percent of its elec-menty. tricity

tricity. The main reason for that, of course, is coal, which was first commercially mined in the Commonwealth in 1820. Now, only two states extract more annually, and only four depend on it more to run their homes, schools and businesses. Here in Kentucky, it supplies more than 90 percent of our electricity. Early this month, during a legislative meeting on clean-coal technology, the director of the University of Kentucky's Center for Applied Energy Research said that coal will for decades or core as our regy for decades or core as our regy for decides or cone as our regy finding ways to make it more efficient and clean. He pointed out that we have antionally, for example, is up almost 80 percent from 1980

nificant successes. Coal use nationally, for example, is up almost 80 percent from 1980 levels, but emissions from sulfur dioxide and nitrogen oxide have declined by more than a third.

Much of the research into clean coal is now focused on two areas. The first is continu-ing to make our power plants more efficient, which is a grow-ing challenge in Kentucky since only a handful are less than 20 years old and most have been around for 40 years or longer. The second area of research is sequestering the carbon diox-ide generated by burning coal. Last year, state researchers dug a test well in Hancock County to investigate the effectiveness of putting this gas deep under-ground, and initial tests have whow promise. Ongoing work will see how this pilot project cally. The same consideration will

cally. The same consideration will be given to a similar process that would actually burn coal at the

would actually burn coal at the source in seams that otherwise cannot be mined. The resulting gas would be collected at the surface as a fuel, with the carbon dioxide returned in its place. The UK director said that other research being done at the university includes such things as using algae to capture carbon dioxide and to serve as a fuel source as well; and finding novel ways to recycle coal ash in such things as cement.

novel ways to recycle coal ash in such things as cement. Three years ago, the General Assembly began budgeting \$3.5 million annually to help further coal research. The UK center now receives \$1 million of that, and the remainder is distributed by the state's Office of Energy

Policy. Other universities are playing critical roles as well when it comes to energy production. Western Kennucky University, for example, is regularly out in the field helping power compa-nies measure and control emis-sions. Isolating mercury is espe-cially tough, since it represents power plant's emissions. The University of Louisville, meanwhile, is taking the lead in help from a \$20 million gift last year that remains the single-largest private donation ever received by one of our public university of attention in Kentucky, energy storage is gaining trac-tion as well. Work is underway to partner with a prestigious fed-eral research lab in Chicago to build a facility to study the next generation of lithum-ion batter-ies, which are used in hybrid and all-clectric vehicles. This is fit-ting, since we are third among the sin auto production. Finding clean and abundant energy has long been 'a chal-lenge for the country, but thère is reason to believe that we are getting closer to that goal. In the end, there likely will not be a one solution, but many, and if will take all of them - from coal to solar power, and from geot-hermal to boimass - to meet our growing needs.





# UK adds six to Hall of Fame

LEXINGTON – The University of Kentucky announced six 2010 inductees into the UK Athletics Hall of Fame. The class includes for-mer UK student-athletes Mike Casey (men's basketball), Steve Flesch (men's basketball), Steve Flesch (men's basketball), Xaplickett (men's basketball), Valerie McGovern Young (cross country, track and field) and Tayshaun Prince (men's basketball). Mike Casey (1968-69, 71) was a threa-time first-team All-SEC (1968, 1969 and 1971) selection in men's basketball. He finished' his career with 1,532 points, currently ranking 1sth all-time on UK's illustrious list of top scorers. Casey aver-aged 17.0 points or more in all three seasons with the Wildcats, including a team-high 200 in his first year on the varity team. The former guard led the team in assists during the 1968-69 season with 129 assists, in addi-tion to leading the team in field-goal percentage (489) and free-throw percentage (4230) during the 1967-68 season. Casey helped UK win three SIEC championships, eam an Elite Eight appearance and also eamed Academic All-America and All-SEC honors in 1971. He was named Kentucky's High School Mr Bastethall in 1966 and was drafted in the eighth round (130th overall) in the 1970 NBA Draft by Chicago.

Steve Flesch (1987-90) played at UK from 1986-87 through 1989-90 and ranks among the top 40 golfers on the all-time FQA Tour career-cam-ings list. 


Kentucky Afield Outdoors: Find a cool stream for summer catfish

VELE MCCLELLAN KENTUCKY AFIELD FRANKFORT - When you open a jar of Bowker's dip bait, the reek from it all but scalds the olfactory nerves in your nasal pas-sages. It smells really, real-ly bad. A wind induced blast of its rank odor can turn a weak stomach. You can't keep the jar open long because the stuff is too vile. It catches the fire out of stream channel atfield. B ap of Kennucky, showing the myiad streams an invers of our state. Kennucky streams with pools of et deep hold suprising numbers of channel catfish. "Channel catfish can survive", said Ron Brooks, director of fisheries for the Kentucky Department of Fish and Wildlife. "Channel cat-fish are naturally a river and stream species. They evolved in the rive."

the rivers." Stream catfishing really shines for fishing the long, hot and sticky days of July and August. Channel catfish in streams bite best during the heat of the day from early afternoon

Streams bitc best during the heat of the day from early afternoon until dusk. Few anglers fish this time of day during summer. "The flow of the streams keeps water temperatures down compared to lakes or a large, almost still river," Brooks said. "This keeps the channel caffish in better condition during the stressful time of summer." Current makes dip bait such a deadly stream channel caffish

Current makes dip bait such a deadly stream channel carfish bait. Anglers fishing the braided rivers of the Great Plains con-cotted rank recipes of rotten cheese, blood and animal parts to lure channel carfish from their lairs. Channel carfish are one of the few species that thrive in the mud and sand shallow rivers of states such as Nebraska, Kanasa and Oktahoma. The dip baits

Dip bait fishing employs small square pieces of a sponge, a 30 circle hook and some weight to keep the mess down. Thread the circle hook through the sponge and wet it. Squeeze out the excess water and use a stick to push the damp sponge down into the dip bait. Ordinary kitchen sponges work for this technique, but the Grecian-style super absorbent sponges found at atto parts stores work best. They soak up much more dip bait. Some companies produce the chocks prevent gut hooking of the channel catfishs and don't get hung on roots, stoften do, Plus, circle hooks make removing channel catfishs much easier than with a treble hook, avoiding painful puncture wounds from the notorious spines near the catfish's mouth and the dorsal spine on its back. Gently lob the dip bait near the channel catfish's habitat, and basie sumcen logs. Boles in the bottom and undercut banks." Brooks said.

the bottom and undercut banks." Brooks said. A root wad or undercut bank near flowing deep water at the head or tail of a hole is a high percentage channel catfish spot. They will also inhabit undercut banks in surprisingly fast water in shoals and rifles. Many stream catfish anglers put their jar of dip bait on the bank and wade to productive spots. This brings welcome heat

relief and allows the angler to make precise casts. A landing; net with a short handle helps deal with a writhing catfish while waist deep. Allow the current to release the scent plume from the dip bait down into the channel catfish's habitat. Channel catfish come equipped with powerful scent detection organs and this foul scent corning downstream grabs their attention. They follow the scent to its source and eat it. "Catfish will eat anything


scent to its source and eat it. "Catfish will eat anything they can get down." Brocks explained. "They are scav-engers. If they have an opportu-nity to eat, they'll take it, on mat-ter what it is. That's why they eat sponges soaked in dip bait." Dip bait isn't the only thing that fools stream channel catfish. They readily devour night-crawlers, pieces of crayfish, hot dogs, catalpa worms, shrimp, chicken livers and even lunch-ment.

"I did some river studies on "I did some river studies on pallid sturgeon in a former job," Brooks said. "I had bologna for lunch one day on the water and I stuck a picce of the bologna on a hook and cast it in the water. I caught a 15-pound blue catfish. Another day, I had salarii for lunch. So, I rolled up a picce of salarni and stuck it on the hook. A huge catfish broke me off. The 20-pound test line just snapped. I think it was a big flathead."

Most stream channel cat-fish run from 3 to 5 pounds, the perfect size for eating. "Fish always taste better

the perfect size for eating. "Fish always taste better, when they come from cool-er water," Brooks said. "Stream fish fight better as well." Don't mope because of the heat-induced slow fish-ing during the day. Get a jar of dip bait, some circle hooks and old sponge and beat the heat by wading a creek or small river for some nice channel catfish.




