Two Women Teachers Injured **Bus and Truck Crash** Near Here Y IS VICTIM

One man was killed and two women teachers were injured early Friday evening when a pipe-laden truck and a Sparks Brothers bus collided, a short distance from the Cow Creek bridge, six miles from here.

Pierce Bailey, 38 years old, of Morgan county, was fatally injured when pipe extending beyond the cab of the truck crashed into the side of the bus, ripping away almost the entire side of the conveyance. Miss Myrtle Franklin, a teach er in the Garrett consolidated school, and Miss Dora Goble, teacher in the Wayland school, both of Prestonsburg, were injured, Miss Franklin seriously. They sat in the seat directly behind Bailey.

# SIX ARE HELD AT **HINDMAN IN HICKS MURDER-ROBBERY**

Aged Knott Man, Former Floyd Citizen, Found Slain on Ball Fork PROBE UNDTR WAY

A half-dozen Knott county men are in jail at Hindman, held as suspects in a murder mystery developing when the body of Hence Hicks, aged farmer and former resident of Stone Coal Creek, this county, was found last Friday morning in a field near his home on the head of Ball Fork, Knott county, where he had been shot to death and robbed.

Hicks, a man of about 65 years, is reported to have carried on his person \$4,100, his life's savings accrued from hard labor and strict frugality, and when found slain no money was in his clothing. A 22-calibre rifle bullet had been fired into the back of his head, the missile passing thru his brain and emerging above sion of money, a circumstance strange to them, they were nabbed as suspects.

Names of those reported as being held as suspects are Pearl Fitzpatrick, George Robinson, Estill Conley, a son other Conley boys, sons of John and Darcus Conley.




