FLOYD CONTRIBUTES MORE THAN 4,000 TO CHANDLER LEAD

Democratic Landslide Recorded by Recent Vote; County Only Damp

CHILDERS, BAILEY WIN

Lieutenant-Governor A. B. "Happy" Chandler is Governor-elect of Kentucky by a majority of more than 94,000 votes, with perhaps a thousand or so votes to be added to his total when the count is completed.

His Floyd county majority was 4,707, with a total of 9,393 votes to 4,686 for his opponent. He carried 41 of the 47 precincts in the county.

Though his Republican opponent, William Dingus, in the race for State Senator, polled a majority in 25 of the county's precincts, Joe P. Tackett carried Floyd county by a margin of 1,113 votes. Mr. Tackett polled 6,848 votes, to 5,735 for Mr. Dingus. Tackett's majority in Pike was 2,080 and in Knott 2,015.

Mell Petry, the Democratic candidate for Representative who was originally sponsored by the United Mine Workers won, over his Republican opponent for Representative from this county, the 93rd district, 7,037 votes to 5,483, carrying 25 precincts.

Floyd county voted for Repeal by 246 votes, though the Dry cause polled majorities in 23 of the 47 precincts. The three Prestonsburg wards gave 441 votes against and 316 for Repeal.

In the most spirited county board of education campaign ever conducted in this county Guy Childers and Harold Bailey, backed by the Town Hall supporters, won over W. W. Cooley and Jack Branham, who were given the support of Superintendent Ballard Hunter, and over two independent candidates, Rommeyn C. Dyer and A. G. Harmon. Childers the leading candidate, polled 5,597 votes and carried 28 precincts over his nearest opponent, Cooley with a tie vote resulting between the two in one precinct. Bailey's vote total was 5,260, Cooley's 5,108. Branham, 4,920, Dyer, 999, and Harmon, 446.

CHILD'S FOOT SEVERED BY MINE CAR WHEELS

A three-year-old son of Mr. and Mrs. Jack Wright, Water Gap, suffered the loss of a foot Monday afternoon when his leg slid onto the wheels beneath the wheels of a mine car. The child was playing when the accident took place, and was dragged 20 feet or more by the car, it was said.

The tot was taken to the Beaver Valley hospital, Martin, where it was said Tuesday that his condition is satisfactory.

TWO JAILED AFTER SCHOOL BURGLARY; DEPOT IS ROBBED

Curtis Sparks, 17 years old, and Mance Weaver, 16, were lodged in the county jail by Policemen Ben Layne and Wood Meade, of Wayland, on a charge of housebreaking.

The officers said the youths had confessed to breaking into the Wayland school building on the night of November 4 and stealing \$2.08 in cash and school supplies valued at \$10 to \$15. They gained entrance to the building by breaking a window.

G. L. Gray, special C. and O. agent, has been concerned with seeking the identity of those responsible for breaking into the railway depots at Dinwood and Lackey recently. From the Lackey depot a case of whisky and two cases of shoes were stolen. At Dinwood the haul was a case of shoes and a shipment of piece goods.

2 HELD HERE AS CRIME SUSPECTS

Are Wanted in Series of Offenses; Arrested Near Here Tuesday

Two men whose names were listed as Chester Terry and Henry Mobbett, both suspected of a series of crimes, were arrested Tuesday night in the old Colonial Coal Company commissary across the river from here, by Sheriff M. T. Stumbo and Policemen Ben Layne and Wood Meade, of Wayland.

Sheriff Stumbo said they are wanted by Ashland police for auto theft. County Judge E. M. Moore, of Knott county, Sheriff Stumbo was told, had offered a reward of \$25 for capture, alleging that they robbed his store. They are suspected of robbing the railway depot at Lackey recently, and Johnny Martin, of Hueysville, said two persons had identified them as the men who deserted his car on Stone Coal Creek where it had been wrecked after being stolen from his garage Saturday night.

A third man against whom no formal charge has been placed when this was written was with the pair when they were arrested. This man is said to have had a high-powered rifle. They offered no resistance.

HAPPY DAYS AGAIN IN FLOYD MINING TOWNS

Hueysville, Ky., Nov. 4.—Payroll of the Elkhorn Coal Corporation at Garrett, this county, Oct. 26, was reported to have been the largest since the boom days of 1917. The same report comes from the company's Wayland mines.

\$9,253 ASSESSED FROM BUS FIRM

As Damages Incurred in Death of Bailey, Injuries to Miss Franklin

A jury in the Floyd circuit court Saturday rendered a verdict for Mrs. Virgie Bailey and Miss Myrtle Franklin, plaintiffs in the suit against the Sparks Brothers Bus Company which arose from the collision of a bus and a truck at Cow Creek in which Mrs. Bailey's husband, Pierce Bailey, was killed and Miss Franklin was seriously injured.

Mrs. Bailey was awarded \$6,000 damages and Miss Franklin, \$3,000, plus \$253 expenses.

Testimony for the plaintiffs alleged that the death of Bailey and Miss Franklin's injury resulted from negligence of the bus driver, McKinley Sparks, president of the Sparks Brothers Bus Company. Defense evidence claimed the bus company was not responsible and that the truck driver, M. C. Sexton, Wayland, sexton, Wayland, caused the wreck.

The judgment is being appealed, and a suit has been filed by the bus company seeking to recover \$3,250 damages. M. C. Sexton and William Sexton, the Lackey Gas Distributing Company and W. E. Lockhart, receiver for the Inland Gas Corporation, are named as defendants.

BLACKCATS TAKE HOMECOMING TILT

In Ding-Dong Battle Here With Van Lear Bank Mules

Fortunately—most fortunately indeed—Cats are alert and active while Mules are yet sleepy, blinking and nonchalant. For when the Mule does kick feline clawings must go for nought.

So the Prestonsburg Blackcats learned last Saturday at their annual pigskin homecoming celebration, with the Van Lear Mules providing the virile and all but fatal visiting opposition. WHEELWRIGHT IN ROLL CALL LEAD

Red Cross Membership There Exceeds Quota Before Drive Started

As the annual Roll Call of Floyd Chapter, American Red Cross, got under way Armistice Day Wheelwright, the Inland Steel Company mining town, reported that it had already passed its goal of 400 members and had almost reached the 500 mark.

With this encouraging news at hand, it is believed that the county will, without delay reach its quota of 1,200 members. Wheelwright each year leads all other Floyd county communities in Red Cross memberships, and this year began its Roll Call drive early, those directing the work there conducting a spirited campaign and finding a willing response to solicitation.

The demand on the resources of the Red Cross is expected to be heavier than ever this winter, since it has been announced that direct relief will end soon. Daily, the local office of Floyd Chapter is visited by persons seeking aid for schoolchildren, many of whom are unable to attend school because of lack of clothing.

"The people of Floyd county annually spend huge sums of money for recreation, entertainment, luxuries and unnecessary things. Surely they will not refuse the Red Cross the small sum asked in this Roll Call drive which is dedicated to the purpose of helping the unfortunate," Miss Ella Noel White, executive secretary of Floyd Chapter, said this week.

Services at Presbyterian Church To Be Conducted Mt. Sterling Pastor

The Rev. I. W. Wilcox, pastor of the Presbyterian Church at Mt. Sterling, is to come to Prestonsburg to lead in a series of evangelistic services at the Presbyterian Church, beginning Sunday, November 17.

Mr. Wilcox will be remembered as the bringer of the ordination sermon at the time of the present minister of the church here, Robert A. Potter. His message was well received.

After graduation at Louisville, Mr. Wilcox served the South Frankfort Presbyterian Church for four years as pastor, and then came to Mt. Sterling, where he has been minister for 10 years. Under his pastorate at Frankfort a \$25,000 education plant was erected, and a new building was also constructed at Mt. Sterling.

MAYTOWN MAN IS INSTANTLY KILLED, TWO ARE JAILED

'Handshake of Death' Charged to Blackburn in Slaying of Slone

SELF-DEFENSE, CLAIM

Emery Slone, 30-year-old Maytown merchant and restaurant-owner is dead with three bullets fired through his head, and Bennie Blackburn, 21, and Bill Baker are held in jail here in connection with his murder.

Slone was killed shortly after midnight Saturday as he sat beside his wife in his truck parked in front of Sadie's Place at Knotley Hollow, a few miles above here.

Blackburn admits shooting Slone but claims that he fired in self-defense. Baker was arrested, it was said, following his statement that he also fired on Slone, but his story is being discredited.

One story of the killing is to the effect that, shortly after Slone had parked his truck in front of the place, Blackburn, with whom the merchant had previously had an argument approached the truck, extended his right hand and asked Slone to "shake and make up." With his left hand, this story says, he drew his revolver and fired.

Frank Blackburn, father of the slayer, said Tuesday that Slone had been looking for his son during the night and had said he would kill Blackburn. Inside the building at Knotley Hollow, this version of the trouble continues, Slone punched Blackburn with his gun and was restrained only through the efforts of others present. Returning to his truck, it is claimed, he asked Blackburn to shake hands. Extending his left hand from the cab of the truck, it is contended, he started to draw a revolver with his right hand. The shooting followed.

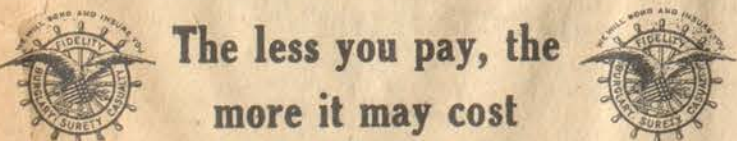

Slone, who sat in the car with her husband's head on her lap for almost two hours before an ambulance arrived, said her husband struck the truck outside Sargent's Place to listen to guitar music and that while they were there Slone and Bill Baker had an argument, after which Baker went inside the building. As Slone was starting the truck, she said, Blackburn came outside, motioned for him to turn down the glass and inquired what was the trouble. Her husband replied, she said, that everything was settled and Blackburn remarked, "You're a real man; put it there," extending his right hand to shake hands and drawing and firing his revolver with his left, this version says.

One bullet penetrated Slone's neck, passing through the jugular and carotid artery, another through his chin ranging downward into the shoulder and the third entering the skull above the left eye.

The victim was a son of Jasper Slone and was born and reared on Middle Creek. He is survived by his widow, six children, his parents and

several brothers and sisters. The body was prepared for burial by G. D. Ryan and was taken to Goodloe for interment Tuesday.

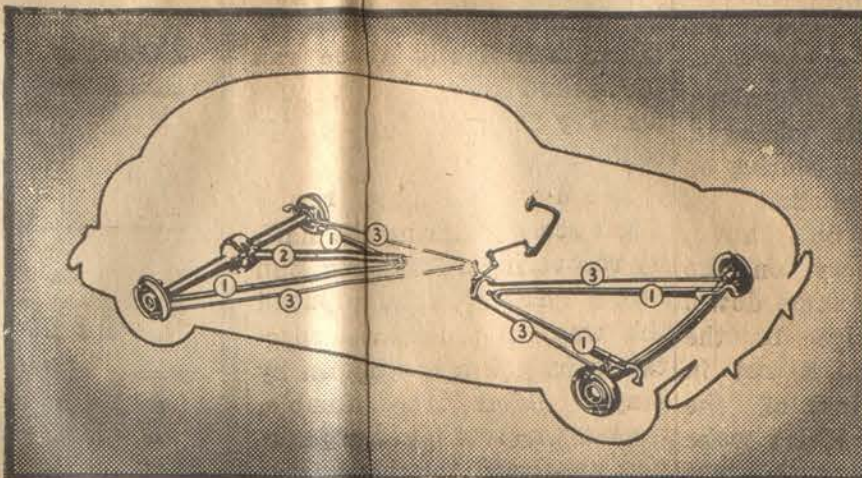

BLACKCATS TAKE HOME-COMING TILT

 Craft's toe put the ball deep into Blue and White territory. Van Lear was forced to punt out, and Prestonsburg took the oval 32 yards from the Johnsonian goal line. The Mules' line held, however; and the 'Cats worked a surprising pass, Dickerson receiving and racing to the two-yard line. From this point Hughes twice rammed against the Van Lear wall to crash over the goal line. Dickerson's placement was good—how good indeed Floyd county fans learned later buoyed up the Blackcats with a one-point margin.

Again Craft booted deep into Van Lear territory, but a Mule kick brought the ball back to his 22-yard line. Van Lear was forced to punt again and the Messer-coached men put the ball in play 40 yards from Blue and White's goal line. Williamson sifted thru the Van Lear line and readily sallied into the end zone for a second Blackcat touchdown. Dickerson's attempt at converting the extra point failed, and the score in the quite young game was Prestonsburg, 13; Van Lear, 0.

Craft again booted the ball

almost to the Mules' goal line, Salyers hopefully waiting for it to go over, but finally having to run it back. After Van Lear backs had negotiated a first down, the visitors were again compelled to resort to the kicking game, and Mayo, Craft and Hughes took the pigskin down to within 12 yards of the Van Lear twice-crossed goal line before the quarter ended.

But when Prestonsburg faced west, affairs changed. There was to be no scoring on the west goal line that day, all the 27 points being made in the end territory on the east. Mayo made first down, Prestonsburg's fifth of the game, and — tell it not in Paintsville—the last of the day! The sleepy Mules woke up, and how energetic was their awakening! Hughes fumbled, and Moles recovered over the goal line for a touch-back.

The Mules, taking the ball on their 20-yard line, were never halted until they had planted their heels in the eastern end zone 80 yards away. The beginnings of the terrific onslaught was a 40-yard pass, Kazee to Green—an augury of more to come—Dickerson, safety nabbing the tall, fleet

Van Learian 38 yards from the 'Cats' goal. Line bucks, a pass to W. King, Kazee's circling of left end, E. King's going right, Kazee's plung, and there the ball was—less than a yard away from Prestonsburg's goal. Two half the distance to the goal off-side penalties were inflicted against the Black and Gold team during its brave stand against the Mules, and finally Kazee ran far around left end for a counter. Try for goal by the pass route failed.

There was no more recognized scoring during the half. By recovering a fumble in Van Lear's territory, P'burg paved the way for what most spectators judged a touchdown by Mayo. After the fumble, Archer was sent into the game, was checked by a fine smashing tackle by Young, but a forward and lateral was apparently consummated after a general mix-up. The linesman ruled the forward had not been completed, however, and the ball was brought back.

In the third quarter came the most sensational play of the game—a toss from Kazee to the pass-devouring Tom Greene, who raced 70 yards through a broken field to plant the ball behind the Prestonsburg goal line. Craft nailed the runner, however, in an attempt at extra point.

The Mules once more threatened, But Mayo cut short their aspirations by intercepting a pass. With the opening of the fourth period the visitors again surged forward, the ever-dangerous Greene snagging another pass to go to the 'Cats 22-yard line, and Kazee swinging through a great gaunt hole to the 15-yard marker. But Prestonsburg braced; and the effort at scoring was ended when Mayo took care of an attempt to pass to Greene.

Unwisely the 'Cats essayed a running play, and Craft fumbled to recover two yards from the Black and Gold Goal line. Mayo stood on his goal line and sent a fine, soaring spiral over the Mules; and E. King, returning, was cut down 42 yards from the Prestonsburg goal.

At last the 'Cats began to take control of the situation, notably by taking charge of Greene. He caught one more pass, but Meadows whacked him down in mid-field, and Prater, going into the game—perhaps with instructions to stay with Thomas Greene at all costs—blocked one heave meant for the tall end and intercepted another. Mayo was constantly outpunting the Van Lear kicker, and the exchanges saw the ball going farther into Van Lear territory. Finally, from within his own end-zone Salyers tried to punt out, but was forced to run with the ball. Desperately, he circled to the left, but Allen nailed him for a safety and the added two points.

The fine work of Craft and Allen, the latter in a substitute role, at ends was a major factor in the Blackcat victory.
