## **RANSDELL SAYS FUND** SHORTAGE HURTS **HEALTH WORK**

Limited funds restrict nursing services of the Floyd county health department to one nurse per 21,000 population, in the face of an apparent need of one nurse to not more than 5.000 population, Dr. Marvin Ransdell, department director, states in his report for the year 1939, released last week

"During the past year," the report points out, "a per capita of something like \$30 has been spent to educate the minds of each pupil in Floyd county. Surviving a tourney of 40 contes- while 3c per capita was spent to pre-

In his discussion of the tasks faced by the health department and of the handicaps which it faces, Dr. Ransdell pointed out that in some school districts as many as 65 to 75 per cent of the children are parasite-infested, some by as many as four types of worms.

The birth rate was placed in the report at "around" 30 to the 1,000 population, while the percentage of deaths was given as at approximatey 9 to the 1,000 population.

Floyd county suffered not at all from smallpox and no deaths resulted from measles during 1939, Dr. Ransdell reports. The smallpox immunizatin in the schools of the county has reached the point where at least 75 per cent

## **KENTUCKY'S BURDEN**

The state of Kentucky maintains at least two asylums for the insane, two institutions of treatment of mental diseases, even if they have, at times, been little more than medieval donjon-keeps.

Anyway, the state pays out the money to house and feed and provide treatment for those of us who are mentally afflicted.

Then why should not the state, ostensibly a body politic dedicated to the protection of the citizens who are its warp and woof, afford the same care and treatment for sufferers from tuberculosis?

Last week there came to the offices of the Floyd county health department an orphan girl, nineteen years old, in the early stages of what folks in some quarters call consumption, an eloquent word, since it describes the eating away of the lungs. She was not begging for money, she was not begging for work. She was begging for the right to live. Like you and me and everybody else, she didn't want to die. Most of all, she cringed from the slow, torturing death that comes from tuberculosis to the sufferer with his or her eyes open, conscious, wide-awake, seeing clearly that death is near, that life must be lived till merciful death arrives, that friends and relatives agonizingly await with the patient the inevitable hour.

But there was no help in sight for this young girl who begged.

Hazelwood Sanitorium, in Louisville, the state's only institution for the care of tuberculosis patients, has no "free beds" at this time. This girl, therefore, must continue to reside with a half-brother. And this halfbrother has a family which includes several small children. She cannot be isolated while she is dying, even. Those children of her half-brother will spend part of their time with her. They may contract the germs of what others call the "White Plague." When they reach the latter stages of adolescence, the period of life when they may begin to 'burn the candle at both ends" with late hours, perhaps dissipation, these children may fall victim because of lowered vitality to the germs which they contracted this year or last, or may contract next year.

On the other hand, the mental patient, the "crazy" person, if kept at home, ordinarily will not communicate his or her disease to those in the home.

Yet that mental patient is given hospitalization at state expense-and God knows they need and deserve all the state can or will afford them-while our tuberculosis patients who are without funds are left to die wherever they are, in whatever surroundings they may be.

\* In all "fairness," then, why should not the tuberculosis patient be given the same attention as the man or woman who is "crazy?" You or I may be stricken by either of the dread maladies. There is no disgrace attached to either, if the patient does not invoke suffering through his or her own act. Either disease is often curable. The more piteous of the two, THE TIMES believes, is that "While Plague" patient who realizes the hopelessness of his or her condition, realizes that he or she contracted the lethal organism innocently, knows that death is the only end of suffering to be expected if prompt treatment is not forthioming.

At Hazelwood Sanitorium the patient financially able to pay \$2.85 a day may receive treatment-if the sufferer is not too late to occupy a bed where the demand for beds is constant. At Hazelwood Sanitorium, there, sometimes, are a few "free" beds for patients such as the Floyd county girl here mentioned. Most of the time, all these "free" beds are already occupied, since this is the only hospital of its kind in the state giving such treatment to tuberculosis sufferers.

That being the case,-a situation wherein all the sufferers cannot receive treatment, wherein only one hospital attempts to serve all the thousands who are afflicted, wherein failure to attend to these, our livingdead, amounts to criminal negligence,-why, in the name of humanity and in behalf of future generations, does not Kentucky provide at least the number of sanitoriums necessary to care for those who otherwise are condemned to death by tuberculosis?

This is not only the state's burden. It is also that of each county in Kentucky. It is the burden of the "white" man-and the definition of a "white" man is one who thinks and feels and sees beyond his own comforts.
