





#### FEBRUARY 12-AND A WARTIME PRESIDENT

SATURDAY of this week, the birth anniversary of an immortal Kentuckian and American will be observed.

In some quarters, as members of the party to which he gave breath and life gather, it will not only be observed but celebrated.

Abraham Lincoln, the Kentucky boy, is one of the country's immortals.

This is the Great Emancipator to whom Americans do honor next Satur-day. The boy from Kentucky who split rails in Indiana and Illinois and who later refused to split "legal hairs" as Pres-ident of a country torn by dissension when the good of the Cause demanded he should break tradition, smash the young but hidebound rules by which the Constitution governed these states of our country.

His Emancipation Proclamation, those who "split hairs" will tell you, was in violation of the Constitution. Others, now long dead, berated him because he did not proclaim the Emancipation months, perhaps a year or two, earlier.

These days, in the perspective provided by the years, the Lincoln boy who first saw the light of day in a Kentucky log cabin is recognized by us all as the one man who kept before him always the shining light of unity for these United States without which this nation could never have grown great; the country boy whose heart failed him at human suffering, whose power of pardon for deserter and foeman alike was exercised in the name of mercy. "Shooting wouldn't do this poor fellow any good,' was the usual comment of the big-hearted Kentuckian. He hated the sight, the thought of blood, did this man whose thoughts transfigured his own homely body, transcended his own earthly home. He was so humble that he often doubted if he was a fit leader of the country in days of strife when discipline was necessary, when bloodshed was inevitable.

The boy in his log cabin, suffering

erty in Kentucky, his manful work in Indiana and Illinois where tragedy deeper than poverty even overtook him, taking from him the girl of his heart, visiting him with business failure, his flashes of humor amid all skies darkening his own horizon-the story of Lincoln, the saga of his rise always upward to the moment when he became "a man of the ages," defies the narrator. All except the acidulous skeptic of all good men and the good all men do in some degree now do him honor.

This was the man who wrote the immortal letter to the widow Bixby, who was ridiculed by men who should have known better for an ageless expression of Americanism at Gettysburg.

#### \* \* \* \* \* \*

And this man Lincoln, whose birth anniversary will be observed with reverence next Saturday, is the same man the Copperheads of the North, the Secessionists of the South, the aristocrats who hated the invasion of the White House by the poor and the meek, called by divers names and epithets—"ape" and "liar" and "dictator" and "felon" and all the bitter, hateful things a man beset by a divided, tortured people could suffer.

Among those who, back in the 60's, defiled the name of Lincoln were Horace Greeley, the country's most influential newspaper editor, and Henry Ward Beecher, the pulpit orator and brother of Harriet Beecher Stowe, author of "Uncle Tom's Cabin." Big "guns" were gunning for Abe Lincoln, those days; this, aside from the shot and shell thrown by Jeff Davis and Robert E. Lee and "Stonewall" Jackson.

Kentucky's Abe Lincoln, whose face was that of a man of sorrows, was accused of granting leaves to soldiers on the battle lines so they could return to their homes and vote for him in the midwar election. This man whose memorial at Harrodsburg exalts Kentucky in the community of states that is the United States of America, was, plainly speaking, if his enemies are worthy of being quoted, an out-and-out rogue, a lout, a scorner of all things noble.

#### \* \* \* \* \* \*

That was eighty years and more ago. Today, we all see through the curtainfalls of the decades glimpses of the fineness that was Abraham Lincoln, the leader of a country torn in internecine strife, the one man who was by every instinct of heart and nature equipped to lead us most quickly to a renewal of the marvelous life that is the communal life of these United States.

#### \* \* \* \* \* \*

The President of this country today has his political problems, as did Abe Lincoln in the '60's. There are today nests of Copperheads remaining, those who want peace, those who hate the President, those who think more of tomorrow's safety and security on the Home Front than they think of the men on the War Front. These are here at home, they are in Congress, they permeate the entire national picture.

And so does the story of "Honest Abe." accused of every sin with which man is beset, dovetail into the story of another
