tory in Somerset, may," The Courier-Journal comments, "be the means of acquainting still other prospective industrialist settlers in Kentucky with the many advantages of the state's least industrialized region."

The Courier-Journal was speaking of Eastern Kentucky.

Now, will someone please inform us where this Smaller War Plants Corporation is located? Months ago when this newspaper was devoting considerable editorial space in an effort to awaken Floyd countians to the need of diversified industries in the post-war years, we were told a representative of the Corporation would soon be in Prestonsburg to discuss possibilities. To date, nothing has de-

This is by no means a criticism of the federal agency. It would seem the burden of presenting Floyd county's case rests on us of Floyd county, rather than that of any governmental agenda. We should, somehow, contrive to present the local picture more effectively to industrialists.

The recent attempt to organize a Floyd County Chamber of Commerce, with all professional and business men from all parts of the county eligible to membership, should have met a better fate. Thus would have been formed a countywide organization to do the spadework necessary to attract industries here. Its scope would have been larger than any similar group organized in any single town of the county; its over-all effect would have been commensurably

Sporadic attempts of one individual, or of a few, to "sell" Floyd county to outside interests work no harm and are admirable but they too often are ineffectual. By this time we should have learned this lesson.

Floyd county's farms and mines and small sawmill operations cannot absorb the surplus of labor that is an inevitable post-war problem. The farms, unless scientific conservation and soil-building are practised, will grow less in the future as a source of revenue and employment: the mines, even in wartime and at full production capacity, are well-manned.

Then to small, diversified industries we must turn if we would stabilize our industry of the future.

It is no job for one or two, this working for the future. We all should do something about it, for it concerns us



TOM WALLACE, for fifteen years editor of THE LOUISVILLE TIMES, has his roots deep in the soil of Kentucky. A fifth generation Kentuckian, he was born at Hurricane and moved to Shelby County when he was a boy. A world-traveler, he has for the past few years pointed his trips toward South America, especially Mexico . . . writing keen, sympathetic articles south of the border. This month he flew to Caracas for a meeting of the Inter-American Press Association of which he is U. S. vice president.

The Wallaces have two children, a daughter, Mrs. Leo Handel, whose son Tommy is named after his grandfather; and a son, Henry, an officer in the Merchant Marine, somewhere in the South Pacific.


