



Fleming and Mrs. Francis Named; Jury's Report Asks Health Dept. Action

Two wilful murder indictments were voted by the Floyd circuit court grand jury during the last two days of its session last week. Last week's work brought to 69 the total of indictments made by the jury.

Named in the murder bills were Ballard Fleming, of Prestonsburg, in the slaying here last May 19, of Don Woods, and Mrs. Corsby Francis, of Neon, in the fatal shooting at Sugar Loaf, near Emma, of her husband, A. B. Francis, last June 25. Bond of \$5,000 was required for each defendant.

Elderly Bud Simpson was named in a voluntary manslaughter bill in the auto death at Drift, April 30, of eight-year-old Fabin Tackett The boy allegedly was struck while walking alongside the highway by a car driven by Simpson.

When James Slone failed to appear before the grand jury to make an indictment against Bennie Blackburn on a charge of shooting and wounding him, Slone's sworn statement, previously signed, was used. Whereabouts of Slone are ought, since he failed to answer trial on a charge of shooting and wounding Deputy Sheriff Joe Wheeler Lewis. His \$2,000 bond was forfeited, and Judge Hill directed that when he is located a new bond of twice that figure be required for his release.

own territory, but they couldn't either. The big difference in the ball game was their powerful line. They could move the ball on the ground and we couldn't. That let them kick us back deep and, more important. gave them much greater defensive

strength to the outside. They had two men on both our flankers, damaging our outside attack, both passing and running. We simply weren't strong enough to yo up the middle and force them to pull their defense in.

In the face of this, two of our fine sophomores-ouarterback Jerry Woolum and end Tom Hutchinson -led the drive to our touchdown and in another drive that barely missed going all the way.

Backed on our own 14-yard line, Hutchinson did a fine job of geting open and caught an 8-vard pass. Then he made a great catch for a 27-yard gain.

That put us in good position and we didn't let the opportunity go by. We felt we could pass under these conditions, and we did. In a remendous drive, we went 86 yards to score.

But we were trying to throw the ball from the first, in good position or not. Pass calls were made three of the first four times we had the ball. Only on the first series did we stick to the ground. We called pass plays from our own 26, 24, and 23 yard lines.

Of the six times we had the ball in the first half, pass plays were called four times-and the farthest upfield we had it was the 28, with the exception of the last half minute.

A lot of people seem to think Ole Miss played conservative football when they punted three times inside our 35 yard line. But this isn't true. They used the kick as an offensive weapon, shoving us into a hole.

Mississippi has made offensive use of the punt for years, kicking on third down from deep in their own territory and on fourth down on the other side of the 50.

As for the decision to kill the clock near the end of the first half, I am still convinced it was the wise thing to do. We were behind only 7-0 and had the ball on our 44 with 33 seconds to play.
