For Those Who Have Waited

THE TIMES is convinced that all things do indeed come to him who waits.

This newspaper is now in its thirty-fifth year, and for most of those years we have been arguing the need of good roads into Eastern Kentucky.

Dewey Lake is in its eleventh year, and ever since its impounding we have been urging the founding of a state park there. And when the area was designated a park but was one in name only we cavilled a bit at state administrations, querulously asking why other lakes and other areas had state parks with all their splendid appointments-lodges, vacation cottages, golf courses, swimming pools, recreation for every member of the family-while this state park here at home remained mainly a fond dream.

We have, on occasion, been impatient in our waiting for those things which we believed were our due. Perhaps we have suffered from what might be called a regional inferiority complex, since we have joined thousands of others in enduring the step-child role, and so it is that we may have failed to appreciate the problems faced by state administrations in building into this mountainous area a modern "trunk" highway and of converting near-virgin territory into a state park.

Yet, though we acknowledge all this, we offer no apology for contending over all these years that Floyd county and Eastern Kentucky deserve the very best that any other part of Kentucky enjoys.

The Times takes no credit for these things finally arriving for those of us who have waited. Bert Combs, a resident of Floyd county and a native of the Mountains, was elected Governor of Kentucky. He knew the needs of the region. And he did something about these needs. To him belongs all the credit.

We hail these things as monumental achievements, because we believe this Mountain Parkway and a real. honest-to-goodness state park will mean much to the future of this and surrounding counties, even to the state as a whole. We believe that in Jenny Wiley State ark lies the hope of the Big Sandy valley as a center of tourism. It appears obvious to us that this park, destined to be second only in beauty and furnishings to Kentucky Village at Kentucky Lake, and the continned development of the Interstate Park at the Breaks of the Mountains, in the headwaters of this river of ours, will open to the nation's tourists a region of rare charm and singular attraction. It follows, of course, that Jenny Wiley State Park and the Breaks Park, in themselves, cannot mean the solution of every problem the area faces as civic and business leaders seek to develop a tourist business which would bring into the area millions of dollars annually. Accommodations at any park are, of necessity, limited, and that is as it should be. This situatoin leaves to private interests-motels, restaurants, shops-the opportunity to grow and use their initiative toward development of the area to their own profit. Once we called this the Promised Land, because it had been promised so much and had received so little. Permit us now to change the name to a Land of Promise. How promising it will be will depend upon individuals, their vision, their initiative and ability to work together for something worthwhile. When Jenny Wiley State Park is dedicated on Saturday, September 22, and its facilities opened, presumably for all time, to the public, let all who have waited and hoped join their friends, neighbors and state officials there as an expression of their interest in better things for Eastern Kentucky.

Those who hang grimly on to their hopes of law and order are rightly concerned about the report that the liquor business in "dry" Floyd county is now organized and on the way to going "big-time."

The Times is concerned, too—has been disturbed for a long time now about the trend the bootlegging business has been taking. It has at intervals, for several years now, warned against what could happen if lawless elements, or those who prefer taking a chance with the law in preference to losing a little sweat at honest work, are permitted to work their way along and gradually take charge. But apparently few agreed with us.

Now, when general concern is expressed, we wonder if the situation is worse than it has been for several years. It could be, and we do not mean to minimize the threat that is posed by the current situation. But we would remind all and sundry that for a long time now whiskey and beer and a variety of other intoxicating beverages have been hauled into Floyd county and distributed to individual bootleggers. And this has been done almost with impunity.

In plain words, the big boys have got away with a great deal for a long time now.

The solution of the problem, at this late date, isn't easy. Yet it's simple. Let the law hit the so-called "bigboys," the source of supply, and all your bootlegging troubles will not only be fewer-those that remain will be little ones.

HISTORY OF THE CHURCH

In the year 1950, a small group of Christians, led by S. C. Honeycutt and C. R. Halstead, met with the following people: Dan Nessler, Ethel Nessler, Tom Fields, Alvin Taylor, Estill Hyden, Eva Hyden, Pauline Sparks, L. B. Fairchild, Garnet Fairchild, R. A. Burke, Alfreda Halstead and Rhoda Brickley. This group met for the purpose of establishing a Church of Christ in Prestonsburg.

This small group of Christian workers, visualizing a need for New Nestament Christianity for the community of Prestonsburg, continued to work, diligently toward this end. Although they were hampered by not having a permanent place to meet, they did not let this stop their progress, for they acquired the use of the Floyd County Courthouse, and with the assistance of the local Christian churches and ministers such as Harold Burnside, Joseph Zavadsky and S. C. Honeycutt, they continued to worship and plan for a Church of Christ in Prestonsburg.

They continued their worship in the County Courthouse until September 15, 1952. On this date a building on Arnold Avenue, owned by the Church of God, became available for purchase. Having a desire for a permanent place of worship, a meeting was called and temporary officers were elected. The following Christians were chosen to serve on the first official board: Elders, Dan Nessler, R. A. Burke, Tom Fields and C. R. Halstead; Deacons, Alvin Taylor, Estill Hyden, L. B. Fairchild. The first official act of this board was to negotiate the purchase of the property that was available on Arnold Avenue.

Realizing their prayers answered, this group of people organized the First Bible School on September 2, 1952, and on that same day, Alvis Ford delivered the first sermon in the newly acquired church building.

The first minister of the congregation was Hondel Adams, a student at Kentucky Christian College.

On January 1, 1953, the KYOWVA Evangelistic Association sent their evangelist, Joe Bronson, to Prestonsburg, to establish a permanent Church of Christ. Brother Bronson stayed from January 13 until March 1 and during that time conducted the first revival on February 1 during which meeting twenty-one new members were added to the church.

On the 10th day of February, 1953, the Commonwealth of Kentucky issued a charter to the Arnold Avenue Church of Christ making it a legal non-profit organization.

The following ministers have served this church since it was organized: Hondel Adams, Clarence Mansfield, Robert Ellenburger, Robert Booth, Joe Chenault, and the present minister, Harold Dicks.

The following growth has taken place: in 1957, an addition was added to the present building consisting of Sunday School rooms, a kitchen, a parsonage, and a baptistry; in December, 1959, the church purchased the adjoining property to the church consisting of a house and lot.

From this small group of 10 members, the church has grown to a present membership of 82.

Carter Caves is citadel of Kentucky history and a phenomenon of natural geology. Legend has it that the fabulous Swift silver mine existed in this area. It is certain that counterfeiters were very active in Carter Caves and that they had access to pure silver. At least one trial resulted in acquittal when it was proven that the silver dollars in question were cast of virgin silver.

As late as 1922 a group of Indians from Oklahoma tried to locate a silver mine from a map belonging to their tribe. And although geologists say there is no silver vein in Kentucky, the legend is deeply rooted. In fact, James Harrod, founder of the irst permanent white settlement west of the Alleghenies, was murdered by his companion while hunting for the Swift mine.



(Continued from Page One) gional librarians are he ping library workers to catalog their collections and are aiming for a composite catalog listing all books in each region. This union catalog will enable the libraries and Bockmobiles to exchange books and offer readers a larger selection.

Many counties cannot afford a professionally trained librarian. To these counties the regional librarian lends professional experience and training with a generous hand. Workshops are held regularly in each region for library and Bookmobile workers. Instructions on cataloging, noting borrower requests, selecting new books, housekeeping, meeting the public and using reference materials are given to make these people more effective.

A significant comment on Kentucky's regional library program came recently from Miss Evelyn Day Mullen, library extension consultant for the Office of Education of the U.S. Department of Health, Education and Welfare.

"The regional library program that has been built in Kentucky in the past five years, the outstanding support of the state government and the tireless efforts of regional supervisors reflect the great enthusiasm of the people for improved library service," Miss Mullen said during a visit to the Department of Libraries in Frankfort. She covers the state and local library programs of 16 states.

Two new regions and regional librarians will go into operation during the next biennium. One of these will be centered around Nicholas county with Carlisle as headquarters. Organization of the second new region will be determined in November by voter-approval or disapproval of the prerequisite tax to qualify as regional headquarters. Three or four counties will be trying for the headquarters status. The Kentucky Department of Libraries envisions most of the state's 120 counties organized eventually into 20 library regions.
