his oratorical powers from his father, who was a Baptist preacher. Clay had the power to hold an audience spellbound: he had a most engaging personality and a pleasing, musical voice that captivated the hearts and ears of his listeners. He is ranked next to Daniel Webster as one of our nation's greatest orators.

Kentucky, the adopted state of both these men, was good to them. The remains of both of these great leaders rest today in the hallowed soil of the state they both loved. Clay's remains lie in a tomb at Lexington, his home town, and there is a beautiful monument at his tomb and a placard by it, which says: "I know no North, no South, no East, no West." Clay's great work as a statesman was like Lincoln's in later years: He sought at all times to try to preserve the Union from disruption. The remains of General Tay-

lor lie at rest in the Taylor Family cemetery at Louisville. He was honcred in World War I by having one of the great military camps named after him-Camp Taylor at Louisville.

Clay and Taylor were both members of the National Republican Party, popularly known as "The Whigs," Henry Clay once rejected him as their candidate from Taylor, when the Whigs had to bite the dust of defeat and nominated Taylor in 1848. Taylor's great popularity as a general over shadowed Clay's great ability as a statesman.




