Driver arrested after hit-and-run

SALYERSVILLE — An 18-month-old child was hit by a vehicle in Magoffin County this past week and, as of press time, was listed in stable condition.

According to reports from the Kentucky State Police, Post 9 in Pikeville received a call that a child had been hit by a vehicle that then left the scene.

Soon after the child was hit, police said the vehicle was located after having been involved in a second traffic accident, the details of which were not specified.

The driver, Stephanie Watkins, 33, was arrested on criminal and traffic charges and is currently lodged at the Big Sandy Detention Center in Johnson County.

The accident is under investigation by Trooper Donnie White.

Shooting suspect surrenders

HAROLD — A Floyd County man is being held on a \$200,000 cash bond after arresting officers say he shot a woman multiple times along Old Harold Road Friday.

Jimmy Thacker Jr., 50, was arrested in Pike County shortly after police say he shot 27-year-old Elizabeth Conn. Police said he fled the scene in a vehicle and was taken into custody

along the Right Fork of Island Creek, in Pike County.

"When they responded, they got a vehicle description and sent that out," said KSP Trooper Shaun Little. "He (Thacker) must have had his cell phone with him and called saying he wanted to turn himself in."

Little said other units who were called to assist spotted the description of Thacker's vehicle that had been sent out over the radio as they were making their way to the scene of the

shooting and that Thacker emerged from a wooded area near his vehicle and was arrested without further incident.

Reports that Conn was shot a total of four times could not be immediately confirmed as Little said he only had information that she had been shot "multiple times" and was later transported to Pikeville Medical Center before treating physicians ordered her

Weekend flooding kills two, destroys homes

PIKEVILLE — A flash flood that Pike County Judge-Executive Wayne T. Rutherford, a five-term judge, said was something "unlike anything" he'd seen during his time in office, dropped nearly 10 inches of rain across Pike County Saturday.

The areas of Raccoon Creek and Harless Creek were hardest hit, according to statements released by county officials in the days following the flooding. Raccoon, it has been reported by emergency officials in Pike County, was close to being completely destroyed.

"It's awful," Rutherford said. "I've never seen anything like it in



Ten inches of rain quickly transformed normally quiet creeks into raging rivers and lakes.

Recovery effort already underway

PIKEVILLE — Agencies across the region are coming to the aid of those who suffered, in many cases, total losses in the aftermath of the flooding that drenched Pike County this past weekend.

With areas such as Raccoon Creek gutted of homes and any other structures caught in the path

of nearly 10 inches of flash flood rains Saturday, and two deaths, the work is fully underway to provide shelter, cleanup, reconstruction and help.

State road crews have suspended routine maintenance to concentrate on critical cleanup and repair work, said Sara George, information officer for the District 12 office in Pikeville.

"We are working during every

available hour of daylight," said Sam Hale, engineering branch manager for Pike County. "Floods are not like dealing with snow and ice. We can run snowplows all night, but when you're trying to repair pavement, clean out culverts and drain tiles, or pull ditchlines, you can't work in the dark. It's too dangerous."

Jail makes payment for treatment

PRESTONSBURG — The Westcare substance abuse program at the Floyd County Detention Center will soon receive a boost in funding.

Jailer Roger Webb offered a check totaling \$15,586 to county officials for approval Friday for continued work with the program. The money will be used for general operations, Webb said.

"This will allow us to keep us this program," Webb said. "It's an important program and it's working, so this money is much appreciated."

The funding comes as a result of the jail applying for a \$138,000 Community Corrections Recovery Program Grant from the Office of Drug Control Policy. The total amount was targeted to develop the program and provide administration for treat-

Coal mine operator gets probation

PIKEVILLE — A coal mine operator who oversaw work at a coal mine on the Pike and Letcher county line has been sentenced in federal court last week for safety violations at the location.

Alger B. Jent, 57, of Kite, did not receive a sentence that will include prison time, but, instead, probation.

The probation stipulates that Jent will not be allowed to own or operate a mine for at least two years.

Jent pleaded guilty in April that he allowed the installment of roof bolts at his coal mine that did not meet the roof control requirements established by the Mines Safety and Health Administration (MSHA). Specifically, those bolts needed to be able to withstand up to 150 pounds of torque.

He was indicted by a feder-

Pikeville College to offer "Teacher Leader" master's program

PIKEVILLE — Beginning with the fall 2010 semester, Pikeville College and Morehead State University (MSU) will work together to offer what has been referred to as "the model Teacher Leader (TL) master's program for Kentucky."

"Pikeville College is excited to collaborate with Morehead State University on the Teacher Leader program," said President Paul Patton. "We are pleased to provide this new opportuni-

ty to our students and to the teachers in this region. This master's degree program focuses on education and leadership, both of which will enhance the classroom experience, advance student learning and develop leadership potential."

Through the partnership, aspiring teacher leaders will register as MSU students, but will attend classes at the Pikeville College campus and online. Classes will be taught by both Pikeville and MSU faculty.

A foundational concept of the TL program is the idea that proven research and educational theories must be tested, tried, and evaluated in today's classrooms. Therefore, program participants will be involved in field-based work in each of the core courses, having opportunity to examine "what is" and compare that with "what may be."

Aspiring Teacher Leaders will be able to choose from three areas of

specialization, including reading/writing (with an option to pursue the national board certification), Interdisciplinary P-5, and middle grades.

While the pain from the loss of life and property is still fresh for those in Pike County, the burden to county government is only just beginning.

Just ask officials in Floyd County, where earlier this year the fiscal court was forced to take out a \$500,000 line of credit to stay afloat. This only happened because county funds are still tied up in paying the costs of last year's Mother's Day flood, as the Federal Emergency Management Agency has continued to drag its feet in providing reimbursements.

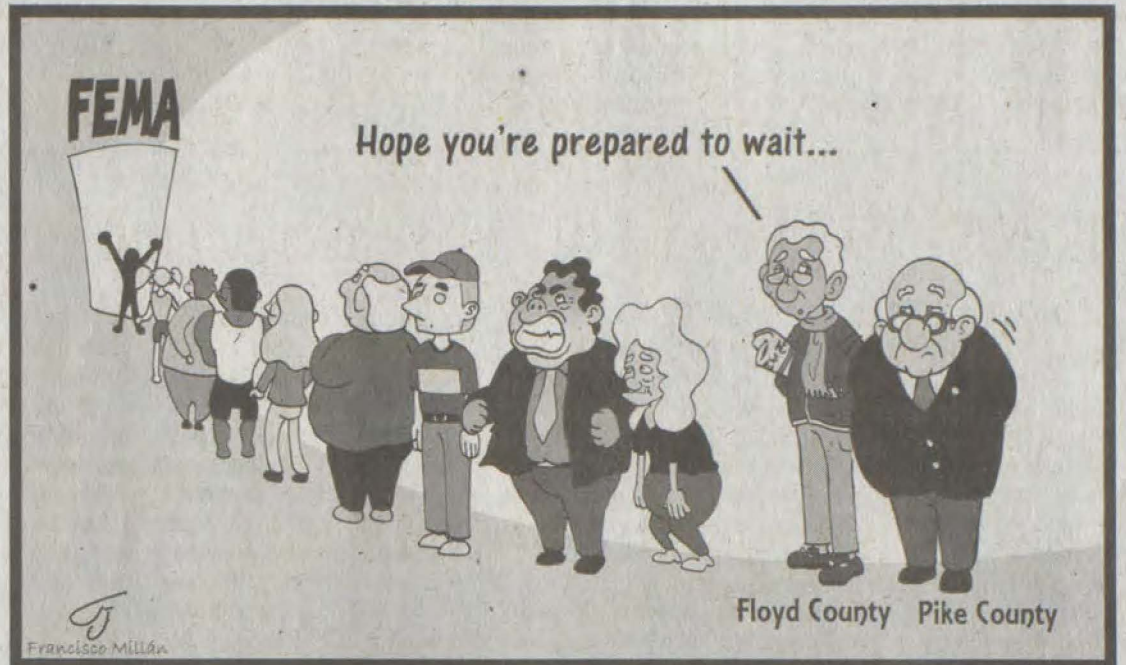
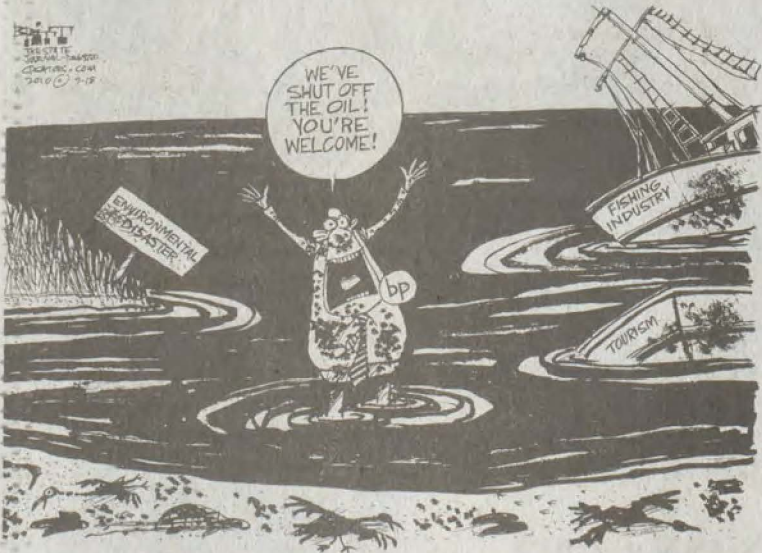
We understand that there has to be a certain level of accountability in government spending. And we are aware that there are some who attempt to take advantage of emergencies, as was the case with the Hobert Meade administration in Johnson County back in the 1990s.

Local governments are fortunate to have the promise of FEMA reimbursement for the bulk of recovery efforts, but that blessing can quickly turn into a curse when the payments are slow to arrive and the ability to meet day-to-day expenses is jeopardized months or years down the road.

A legislative perspective

When it comes to supplying the energy that powers our country, Kentucky plays a bigger role than most. We represent just 1.4 percent of its population, but provide 2.3 percent of its electricity.

The main reason for that, of course, is coal, which was first commercially mined in the Commonwealth in 1820. Now, only two states extract more annually, and only four depend on it more to run their homes, schools and businesses. Here in Kentucky, it supplies more than 90 percent of our electricity.

Early this month, during a legislative meeting on clean-coal technology, the director of the University of Kentucky's Center for Applied Energy Research said that coal will remain a major source of energy for decades to come as our need for electricity grows. The key is finding ways to make it more efficient and clean.

He pointed out that we have already experienced some significant successes. Coal use nationally, for example, is up almost 80 percent from 1980 levels, but emissions from sulfur dioxide and nitrogen oxide have declined by more than a third.

Judd's comments are evidence she is out of touch with realities of region

The recent public comments by Ms. Ashley Judd regarding the people of East Kentucky, the practice of mountaintop removal, and the coal industry in general, struck a nerve with many Kentuckians, rightfully so. Coal, particularly the practice of mountaintop removal, has been, and will continue to be, a controversial subject of debate as America moves toward "clean energy" and "energy independence." That issue is out of the scope for this argument.

Ashley makes several plausible statements within her arguments, and she is well within her rights to do so. However, Ms. Judd misses the point in the fact that she does not, nor likely will she ever, actually live in East Kentucky. She refers to coal industry leaders as "cunning, callous and greedy outsiders." Her views toward the region can be viewed as much of the same.

In his 1962 book *Night Comes to the Cumberlands: A Biography of a Depressed Area*, the late Whitesburg author, lawyer, and professor, Harry Caudill, shed light to the nation about the social and economic distress prevalent throughout the coalfields of Central

Much of the research into clean coal is now focused on two areas. The first is continuing to make our power plants more efficient, which is a growing challenge in Kentucky since only a handful are less than 20 years old and most have been around for 40 years or longer.

The second area of research is sequestering the carbon dioxide generated by burning coal. Last year, state researchers dug a test well in Hancock County to investigate the effectiveness of putting this gas deep underground, and initial tests have shown promise. Ongoing work will see how this pilot project affects the storage-site geologically.

The same consideration will be given to a similar process that would actually burn coal at the source in seams that otherwise cannot be mined. The resulting gas would be collected at the surface as a fuel, with the carbon dioxide returned in its place.

The UK director said that other research being done at the university includes such things as using algae to capture carbon dioxide and to serve as a fuel source as well; and finding novel ways to recycle coal ash in such things as cement.

Three years ago, the General Assembly began budgeting \$3.5 million annually to help further coal research. The UK center now receives \$1 million of that, and the remainder is distributed by the state's Office of Energy

Policy.

Other universities are playing critical roles as well when it comes to energy production. Western Kentucky University, for example, is regularly out in the field helping power companies measure and control emissions. Isolating mercury is especially tough, since it represents just one part per billion of a power plant's emissions.

The University of Louisville, meanwhile, is taking the lead in studying renewable energy, with help from a \$20 million gift last year that remains the single-largest private donation ever received by one of our public universities.

While energy production may understandably be drawing a lot of attention in Kentucky, energy storage is gaining traction as well. Work is underway to partner with a prestigious federal research lab in Chicago to build a facility to study the next generation of lithium-ion batteries, which are used in hybrid and all-electric vehicles. This is fitting, since we are third among the states in auto production.

Finding clean and abundant energy has long been a challenge for the country, but there is reason to believe that we are getting closer to that goal. In the end, there likely will not be a one solution, but many, and it will take all of them - from coal to solar power, and from geothermal to biomass - to meet our growing needs.

Appalachia. This provocative book, written by one of our own, ruffled the feathers of many people living both within and outside of the region. It also caught the attention of the federal government. Caudill, an outspoken critic of the coal industry, became somewhat of a spokesperson for Appalachia. However, not only did Harry Caudill advocate for change in the region, but he also lived here. He was one of us. He understood the role the coal played in the region, but realized perplexities often associated with it. Caudill, although controversial, had a vested interest in advocating for change in Appalachia, not only because his observations and personal convictions, but because he lived here.

Presently, environmentalists, including Ashley Judd, "lash out" against our coal industry through press conferences, propaganda, books, scholarly articles and rallies in Frankfort and Washington D.C. This vilification of the coal industry comes with little willingness to understand the positive impact coal, and mountaintop removal, has for the people of East Kentucky and American society. Much of this can be attributed to the fact that many of these environmentalist don't even live here. They do not understand.

There is no denying the continued diversification our region's economy, to one not as reliant on the "boom and bust" conditions associated with the

demand for coal, would reap benefits for East Kentucky. However, many of the changes advocated for by environmentalists are not only off base, but simply unrealistic. Ashley Judd, who refers to East Kentucky as the place her family has called home for many generations, and which she adamantly proclaims to be so "proud" of, chooses to live outside the area. It is quite possible she is as out of touch as the "cunning, callous and greedy outsiders" she mistakenly portrays the coal industry leaders to be.

Mountaintop removal provides jobs for our people, flat land for development and energy for America. However, it is apparent; one can't fully appreciate these positive impacts unless one actually lives here.

Many people in East Kentucky would likely be more receptive to Ms. Judd's criticisms of coal if she, like Harry Caudill, actually chose to reside here. I commend Ashley Judd on her success as an actress, her recently obtained degree from Harvard, and her continual support of our UK Wildcats. However, this does not qualify her to be a spokesperson for our region, a region which she obviously does not understand.

all my years of public service. "It's a disaster if I've ever seen one."

The total damages are, at this time, unable to be determined, as the losses were so widespread.

And that loss, unlike the flooding that took place in May, claimed the lives of two county residents.

Reports from Kentucky State Police Post 9 in Pikeville say that Craig Morris, of Carrie, stopped on a bridge along U.S. 119 in the Zebulon community, and got from his car to look over the northbound shoulder into the Raccoon area.

Police say Morris was attempting to check on a family member's residence when he fell from the bridge. He was pronounced dead at the scene.

The second person who officials have confirmed as having died during the flooding was Chloe Creek resident Donna Sue Walters.

On Sunday there were still several people reported as missing but by Monday, Pike officials released statements saying that all those who had been

reported missing were accounted for.

The Christian Appalachian Project started training volunteers to help in victim recovery and cleanup Monday morning at the First Presbyterian Church in Pikeville, said Pike County Emergency Management Director Doug Tackett.

Tackett said also that volunteers were needed to help field calls at his office and that bottled water was badly needed at Kimper, Johns Creek and Millard Fire Departments to be dis-

tributed to those in need.

"We have established several water distribution points throughout the county," Tackett said. "All of them either have water or have water on the way."

Over 7,000 people were left without power after the flood but that number was growing smaller by Monday, officials said.

Gov. Steve Beshear toured the county Sunday with Rutherford to access damage following his declaration of a state of emergency for the county.

Recovery

Though Floyd County was spared flooding, crews from Allen and Minnie have worked in the past several days along with those in Pike, hauling water on Sunday and again Monday for the county's emergency management services.

Both Operation UNITE and PRIDE are currently

collecting items for the victims of the flood. Both organizations are actively accepting donations.

"Everything is needed right now, from baby wipes to furniture," said Karen Engle, Operation UNITE's director. "Several rural communities have been devastated and thousands of

families affected. Many people have lost everything they own."

A trailer load of items was transported by the non-profit organizations Monday including bottled water and toiletry items. Eighty cases of sports drinks came from the London-Laurel County

Tourism Commission.

"There's no words to describe it," said UNITE Coalition Coordinator Tom Vicini, who has been in the Raccoon and Harless Creek areas. "The destruction left me sick and heartbroken."

al grand jury in January, pleading guilty to ignoring the MSHA guidelines during the summer of 2008.

"Those who flout the nation's mine safety and health laws and endanger miners' lives will be held accountable for their crimes," said MSHA's Assistant Secretary of

Labor Joseph Main in a statement released following Jent's sentencing.

During an inspection of the mine, MSHA officials discovered of the approximately 60 roof bolts at the location about one-third of them had "turned and were not adequately torqued." According to mining regu-

lations in Kentucky, a fully grouted resin bolt that turns is not properly set and cannot support a mine roof.

The investigation that led to Jent's indictment was conducted by the Special Investigation Unit at MSHA's District 6 headquarters in Pikeville.

Deadline for ARC mini-grants extended

SOMERSET — Officials in Floyd County have a little extra time to apply for funding from the Appalachian Regional Commission after a decision by the Center for Rural Development to extend the grant application deadline to July 30.

The grant applications are for the second cycle of mini-grants from the Appalachian Regional Commission to be awarded in 2010 through the Developing and Implementing Community Strategies Program of the Center for Rural Development.

Floyd County Judge-Executive R.D. "Doc" Marshall hopes to receive some of the funds for a new

project in the county.

"We are going to throw our hat in the ring," Marshall said. "We would use the funds for planning to create a community and recreation center. The funds would enable us to try something like the Knott County Sportsplex. It would be some money to get a target on the situation."

Earlier this year, six communities and organizations in southern and Eastern Kentucky were awarded \$54,800 in mini-grants for the first cycle of funding through the program.

The individual project awards can range from \$5,000 up to a maximum of \$10,000, and all of the projects are required to be completed within a period of six months.

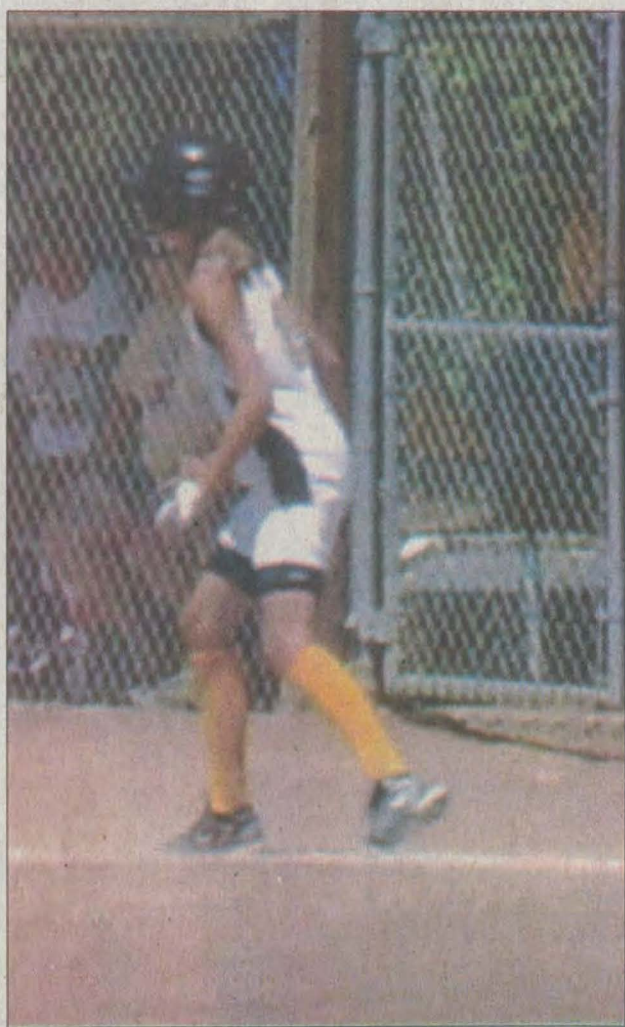

The class will be formally inducted during Hall of Fame Weekend, Sept. 10-11, in conjunction with the football game against Western Kentucky.

Mike Casey (1968-69, 71) was a three-time first-team All-SEC (1968, 1969 and 1971) selection in men's basketball. He finished his career with 1,535 points, currently ranking 13th all-time on UK's illustrious list of top scorers. Casey averaged 17.0 points or more in all three seasons with the Wildcats, including a team-high 20.0 in his first year on the varsity team. The former guard led the team in assists during the 1968-69 season with 129 assists, in addition to leading the team in field-goal percentage (.489) and free-throw percentage (.823) during the 1967-68 season. Casey helped UK win three SEC championships, earn an Elite Eight appearance and also earned Academic All-America and All-SEC honors in 1971. He was named Kentucky's High School Mr. Basketball in 1966 and was drafted in the eighth round (130th overall) in the 1970 NBA Draft by Chicago.

Steve Flesch (1987-90) played at UK from 1986-87 through 1989-90 and ranks among the top 40 golfers on the all-time PGA Tour career-earnings list. Flesch has won more than \$17 million as a professional and has four PGA victories, the 2003 HP Classic of New Orleans, the 2004 Bank of America Colonial, the 2007 Reno-Tahoe Open and the 2007 Turning Stone Resort Championship. He turned pro in 1990 on the Nationwide Tour and won the Nike Tour Championship in 1997, earning

exempt status on the PGA Tour in 1998. In 2001, Flesch ranked second behind Tiger Woods in top-10 finishes with 13. One of three UK medalists in Johnny Owens Invitational history, he was a two-year member of the SEC Academic Honor Roll and named to the Kentucky Golf Hall of Fame.

Nancy Napolski Johnson (1993-96) was a UK Rifle All-American and Olympic gold-medal winner for the United States. She captured the individual national championship in air rifle in 1994 and was a three-time first-team All-American (1994, 1995 and 1996). Napolski Johnson led the team to three consecutive third-place finishes at the NCAA Championships from 1994-96. She continued competitive shooting after her collegiate career and won the gold medal in women's 10-meter air rifle in the 2000 Olympics. She also went on to win gold medals at several other international events.

Billy Ray Lickert (1959-61) was a three-time, first-team All-SEC selection in men's basketball, including a second-team All-America selection by the Helms Foundation in 1961. He ranks 47th on Kentucky's all-time scoring list with 1,076 points. Lickert was named to the 1961 NCAA All-Region Team and led the team in scoring during the 1959-60 and 1960-61 seasons, averaging 14.4 points per game in his junior year and 16.0 in his senior campaign. He finished his career with a 14.7 scoring average and was also UK's leader in field-goal percentage in 1959-60 (.401) and 1960-61 (.420). Named the SEC "Sophomore of the Year" following the 1959 season, his team advanced to two NCAA Tournaments during his three years. Lickert was drafted in the fifth round (No. 45 overall) of the 1961 NBA Draft by the Los Angeles Lakers.

Valerie McGovern Young (1988-91) won three individual national championships in the 5,000-meter run and was the leader of the 1988 cross country team that won the NCAA national championship. McGovern Young was UK's

top performer at the 1988 national meet, finishing second individually. An eight-time All-American in cross country and track, McGovern Young won eight individual SEC championships, including cross country, 3,000-meter indoor, 5,000-meter indoor (twice), 3,000-meter outdoor (twice) and 5,000-meter outdoor (twice). She still holds five UK track records: 3,000-, 5,000- and 10,000-meter outdoor and the 3,000- and 5,000-meter indoor.

Tayshaun Prince (1999-02) was a two-time men's basketball Associated Press All-American, garnering second-team honors in 2001 and third-team honors in 2002. Prince was named the SEC Player of the Year in the 2000-01 season by both the AP and the league's coaches and was a three-time All-SEC selection (2000, 2001 and 2002). He ranks eighth on UK's all-time scoring list with 1,775 points and third on UK's all-time 3-point field goals made list with 204. Prince helped lead the Wildcats to three Sweet 16 appearances (1999, 2001 and 2002) and an Elite Eight appearance (1999). He was drafted in the first round (23rd overall) in the 2002 NBA Draft by the Detroit Pistons. Prince helped lead Detroit to the 2004 NBA Championship and was named to the NBA's 2005 All-Defensive second team. He was also a member of the 2008 gold-medal Olympic team.

The UK Athletics Hall of Fame was started in 2005 to recognize and honor persons whose participation and contributions enriched and strengthened the University's athletic program. The charter class included 88 individuals who had previously had their jersey retired by UK.

There is a five-year waiting period — after leaving UK — to be eligible for inclusion into the Hall of Fame and a 10-year waiting period to have a jersey retired. An individual must be a member of the Hall of Fame to be eligible for jersey retirement.

A committee consisting of Hall of Famers, media members, campus representatives, and current coaches and administrators elects new inductees each year.

Kentucky Afield Outdoors: Find a cool stream for summer catfish

FRANKFORT — When you open a jar of Bowker's dip bait, the reek from it all but scalds the olfactory nerves in your nasal passages. It smells really, really bad. A wind induced blast of its rank odor can turn a weak stomach. You can't keep the jar open long because the stuff is too vile.

It catches the fire out of stream channel catfish.

Blue braids wind all over a map of Kentucky, showing the myriad streams and rivers of our state. Kentucky streams with pools 6 feet deep hold surprising numbers of channel catfish.

"Channel catfish can survive anywhere a bluegill or a longear sunfish can survive," said Ron Brooks, director of fisheries for the Kentucky Department of Fish and Wildlife. "Channel catfish are naturally a river and stream species. They evolved in the rivers."

Stream catfishing really shines for fishing the long, hot and sticky days of July and August. Channel catfish in streams bite best during the heat of the day from early afternoon until dusk. Few anglers fish this time of day during summer.

"The flow of the streams keeps water temperatures down compared to lakes or a large, almost still river," Brooks said. "This keeps the channel catfish in better condition during the stressful time of summer."

Current makes dip bait such a deadly stream channel catfish bait. Anglers fishing the braided rivers of the Great Plains concocted rank recipes of rotten cheese, blood and animal parts to lure channel catfish from their lairs. Channel catfish are one of the few species that thrive in the mud and sand shallow rivers of states such as Nebraska, Kansas and Oklahoma. The dip baits

those anglers invented work for channel catfish in streams across the country.

Small companies that often grew from garage tinkering manufacture much of the dip bait on the market. An Internet search quickly reveals several dozen. Department stores and tackle shops sometimes carry it as well.

Dip bait fishing employs small square pieces of a sponge, a 3/0 circle hook and some weight to keep the mess down. Thread the circle hook through the sponge and wet it. Squeeze out the excess water and use a stick to push the damp sponge down into the dip bait. Ordinary kitchen sponges work for this technique, but the Grecian-style super absorbent sponges found at auto parts stores work best. They soak up much more dip bait.

Some companies produce soft plastic worms and strips for holding dip bait, but for streams, nothing beats a sponge.

Circle hooks prevent gut hooking of the channel catfish and don't get hung on roots, sticks or logs as treble hooks often do. Plus, circle hooks make removing channel catfish much easier than with a treble hook, avoiding painful puncture wounds from the notorious spines near the catfish's mouth and the dorsal spine on its back.

Gently lob the dip bait near the channel catfish's habitat. "They really like getting under and beside sunken logs, holes in the bottom and undercut banks," Brooks said.

A root wad or undercut bank near flowing deep water at the head or tail of a hole is a high percentage channel catfish spot. They will also inhabit undercut banks in surprisingly fast water in shoals and riffles.

Many stream catfish anglers put their jar of dip bait on the bank and wade to productive spots. This brings welcome heat

relief and allows the angler to make precise casts. A landing net with a short handle helps deal with a writhing catfish while waist deep.

Allow the current to release the scent plume from the dip bait down into the channel catfish's habitat. Channel catfish come equipped with powerful scent detection organs and this foul scent coming downstream grabs their attention. They follow the scent to its source and eat it.

"Catfish will eat anything they can get down," Brooks explained. "They are scavengers. If they have an opportunity to eat, they'll take it, no matter what it is. That's why they eat sponges soaked in dip bait."

Dip bait isn't the only thing that fools stream channel catfish. They readily devour night-crawlers, pieces of crayfish, hot dogs, catappa worms, shrimp, chicken livers and even lunch meat.

"I did some river studies on pallid sturgeon in a former job," Brooks said. "I had bologna for lunch one day on the water and I stuck a piece of the bologna on a hook and cast it in the water. I caught a 15-pound blue catfish. Another day, I had salami for lunch. So, I rolled up a piece of salami and stuck it on the hook. A huge catfish broke me off. The 20-pound test line just snapped. I think it was a big flathead."

Most stream channel catfish run from 3 to 5 pounds, the perfect size for eating. "Fish always taste better when they come from cooler water," Brooks said. "Stream fish fight better as well."

Don't mope because of the heat-induced slow fishing during the day. Get a jar of dip bait, some circle hooks and old sponge and beat the heat by wading a creek or small river for some nice channel catfish.

"We are joining a small number of health care facili-

ties nationwide that are providing the public with uncensored information about the quality of their care, based on nationally developed and endorsed measures," said Gene Woods, CEO of SJHS. "By sharing this information so openly, we hope to give consumers power in their decision-making. This information will also be used by our staff and physicians to further improve our patient care processes and share best practices among our hospitals. The bottom line is that patients have a right to know how their

health care provider is performing according to nationally recognized quality standards, and we wanted to make it easy for patients to access our data to make informed decisions about where to receive the best care. We strongly believe it is important to do so proactively without waiting for a legislative mandate."

Consumers can access performance information for all SJHS facilities at SaintJosephQuality.org, a user-friendly site that will be updated quarterly to reflect how SJHS score against nationally-validated measures that guide patient care, including those established by the Centers for Medicare and Medicaid Services (CMS). These national "Core Measures"

monitor a variety of evidence-based, scientifically researched standards of care which have been shown to result in improved clinical outcomes for patients.

With the click of a mouse, consumers can search by medical condition or surgical procedure. For example, a consumer can find out what percentage of heart attack patients at a SJHS facility receive an aspirin upon arrival, and can compare that to the national and state averages. A Core Measure for heart attack, administering aspirin on arrival helps reduce heart damage and increases a patient's survival rate. 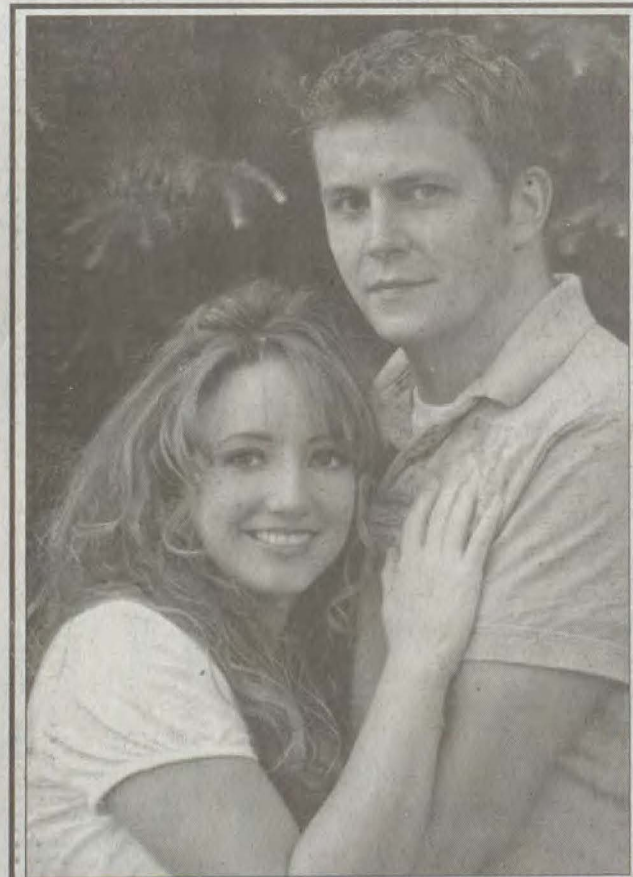

Salad safety: It's in the bag

Who says you can't learn anything from the movies?

I'm a real movie fiend, as you may have gathered if you're a regular reader of this column, and I've picked up quite a few useful tricks over the years from my celluloid buddies.

For example, I used to hack away at a head of lettuce, trying to whack chunks of leaves off the lettuce core (and barely missing my fingers in the process). Then I saw Alan Alda turn a head of lettuce core-down and give it a hearty whack on the kitchen counter in the 1986 film "Sweet Liberty," and voila — that core comes right out in one tidy, solid chunk. That technique has definitely boosted my salad skills!

Maybe you're not into cutting up veggies for your summer salads, and the truth is that you don't really have to, with all the convenient bagged salads available. And with the various projects under way by scientists of the Agricultural Research Service (ARS), you don't have to worry about whether you're swapping nutritional goodness (or even food safety) for convenience.

It's true that cutting fresh produce during harvesting removes natural protective barriers on the plant tissue, exposing the cut surfaces to potential contaminants. But it's also known that irradiating salad leaves after washing (something the produce company would do, not you the consumer) can reduce harmful microorganisms.

In a recent study, ARS scientists looked at the effects of various levels of radiation on concentrations of four vitamins and four carotenoids in two popular baby-leaf spinach cultivars. The Food and Drug Administration has approved up to 4 kiloGrays (kGy) of irradiation for fresh iceberg lettuce and spinach; in the ARS study, the scientists used no more than 2 kGy.

For the study, the scientists grew, harvested, sanitized and bagged the baby-leaf spinach according to industry practices. Each cultivar was packaged in both air or nitrogen gas as used by industry to extend shelf life, and then exposed to up to 2 kGy of radiation in increments of 0.5 kGy.

Then the scientists tested the leaf tissues for concentrations of vitamins C, E, K and folate (sometimes called vitamin B9) and the four carotenoids lutein/zeaxanthin, neoxanthin, violaxanthin and beta-carotene. The findings: The folate, E, K and neoxanthin exhibited little or no change in concentration with the increasing levels of irradiation.

The levels of lutein/zeaxanthin and beta-carotene — which make up 80 percent of all carotenoids in spinach — were reduced on average by 12 percent at the 2 kGy level, but that's within the range of natural variation.

And while the irradiation reduced ascorbic acid levels by 42 percent, that was mainly because the irradiation turned the vitamin C into an oxidized form called dehydroascorbic acid. But that converted ascorbic acid provided the very same nutritional benefits as vitamin C inside the leaf.

That's the good news on the nutritional front ... so what about the food safety angle?

ARS scientists also have looked at differences in bacterial growth on lettuce leaves bagged under very low oxygen levels — an atmosphere that's known to extend the length of time that bagged salad appears fresh.

The question was whether the lack of oxygen would make it harder for the bacteria to survive the shock of exposure to human stomach acids. In fact, the scientists found, in response to the challenge of being an oxygen-starved environment, plus the added nutrients provided by the cut leaves, the bacteria actually became hardier during storage. But that only happened when the bagged lettuce was

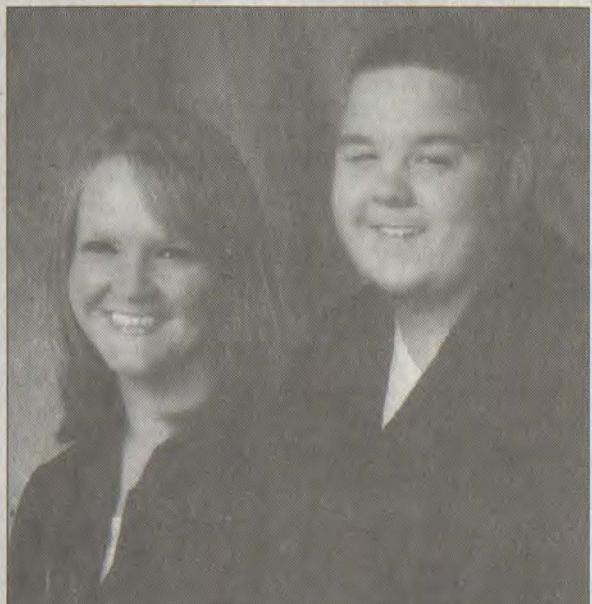

left at room temperature or unrefrigerated for long periods of time.

Next, the scientists applied bacteria to fresh-cut lettuce and stored it in sealed bags under different atmospheric conditions for eight days. When stored under very low oxygen conditions — and warmer temperatures — the bacteria showed more resistance toward synthetic gastric juice (a man-made version of human stomach acids).

The bottom line? You shouldn't leave your fresh-cut produce at tem-

peratures of 59 degrees Fahrenheit or higher, especially when low oxygen levels have been used to extend the shelf life of the bagged lettuce. But the scientists say that if you keep your bagged salad in the fridge, set at 40 degrees F or below, it's good to go!
