STATEMENT

To the Commissioner of Patents:

Elk Horn Coal Corporation, a corporation duly organized under the laws of the State of West Virginia, and located at Cincinnati, Ohio, and Frankfort, Kentucky, and by its receiver, C. W. Watson, doing business at Transportation Building, Cincinnati, Ohio, and Frankfort, Kentucky, has adopted and used the trade-mark shown in the accompanying drawing, for COAL, in Class 1, Raw or partly-prepared materials, and presents herewith five specimens showing the trademark as actually used by applicant upon the goods, and requests that the same be registered in the United States Patent Office in accordance with the act of February 20, 1905.

The trade-mark has been continuously used and applied to said goods in applicant's business since January 10, 1934.

The word "Brands" and the abbreviation
"B T U" are disclaimed apart from the mark
shown on the drawing.

The trade-mark is applied or affixed to the goods, or to the packages containing the same, by placing thereon a printed label on which the trade-mark is shown, and also by stencilling or otherwise displaying the mark on bags, cars, trucks, and containers for the goods, as well as by distributing printed disks disclosing the mark in the loads for sale and transportation purposes.
