#### STATEMENT

To the Commissioner of Patents:

Howard N. Eavenson, W. W. Goldsmith, and J. J. Moore, receivers for The Elk Horn Coal Corporation, a corporation duly organized under the laws of the State of West Virginia, located at Charleston, West Virginia, and doing business at 308 Union Building, Charleston, West Virginia, have adopted and used the trade-mark shown in the accompanying drawing, for BITUMINOUS COAL, in Class 1, Raw or partly prepared materials, and present herewith five specimens showing the trade-mark as actually used by applicants upon the goods, and request that the same be registered in the United States Patent Office in accordance with the act of March 19, 1920.
