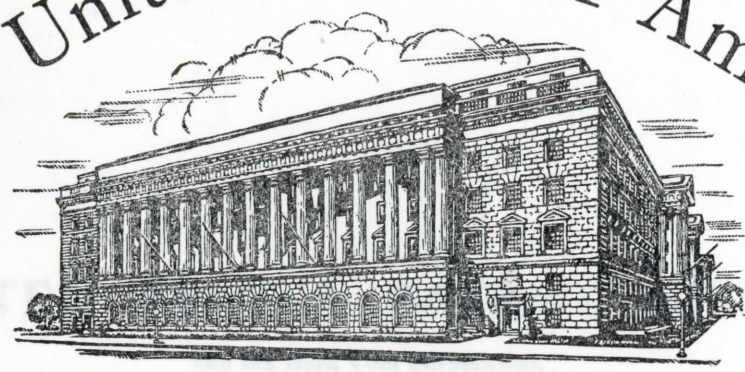

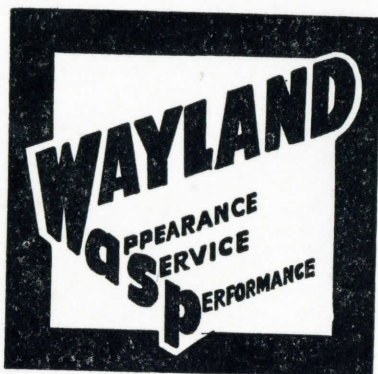

## STATEMENT

*To all whom it may concern:*

Be it known that The Elk Horn Coal Corporation, a corporation duly organized under the laws of the State of West Virginia, located at Charleston, West Virginia, and by its receivers, Howard N. Eavenson, W. W. Goldsmith and J. J. Moore, doing business at 308 Union Building, in the city of Charleston, county of Kanawha, State of West Virginia, has adopted and used the trade-mark shown in the accompanying drawing, no claim being made to the words "appearance," "service" or "performance" and the word "Wayland" apart from the mark, for COAL, in Class 1, Raw and partly prepared materials, and presents herewith five (5) specimens showing the trade-mark as actually used by applicant upon the goods, and requests that the same be registered in the United States Patent Office in accordance with the act of February 20, 1905, as amended. The trade-mark has been continuously used and applied to the goods in the applicant's business since January 10, 1934, and in its present form since March 8, 1943.

The applicant is the owner of registration No. 316,852, issued September 4, 1934.

The trade-mark is applied or affixed to the goods, or to the packages containing the same, by placing thereon a printed label on which the trade-mark is shown, and also by stencilling or otherwise displaying the mark on bags, cars, trucks and other containers for the goods, as well as by distributing printed cards disclosing the mark in the loads for sale and transportation purposes.

The undersigned hereby appoints Charles R. Allen, Washington Loan and Trust Building, Washington, D. C., registry No. 11,276, its attorney, with full power of substitution and revocation, to prosecute this application, to make alterations and amendments therein, to sign its name to the drawing, and to transact all business in the United States Patent Office connected therewith.
